
Graduates of CAAHEP –accredited programs may be eligible to sit for the American Association of Medical Assistants certification examination to become certified Medical Assistants. Upon passing the exam, graduates can hold the credential of CMA (AAMA) which is the most recognized and accepted credential of employers.

The Medical Assisting curriculum prepares students to perform a variety of administrative and clinical duties which includes instruction in anatomy and physiology, administrative procedures, Exam Room procedures, Drug Therapy, Law and Ethics and much more.

To complete the Program, students are required to participate in a Clinical Experience where they can apply what they have learned, further develop their skills and learn much more under the supervision of experienced Medical Assistants!

CMA (AAMA) VS RMA

CERTIFIED MEDICAL ASSISTANT

- The Gold Standard Certification
- Certified by AAMA (American Association of Medical Assistants)
- Requires certification every 5 years
- Preferred credential by many states or institutions
- Exam consist of 200 questions covering clinical, administrative and general medical assisting knowledge.
- Not currently available for students who complete the Diploma Option

REGISTERED MEDICAL ASSISTANT

- Considered Registered by AMT (American Medical Technologist)
- Eligible for students who choose the Diploma Option
- Exam is an average of 200-210 questions covering clinical, administrative, and general medical assisting knowledge.

Occupational Risks

As with any healthcare position, there are certain occupational risks that come into play with being a medical assistant, and those hazards include the following:

Risks:

- Exposure to Infectious Diseases
- Sharps injuries
- Bloodborne pathogens and biological hazards
- Chemical and Drug Exposure
- Ergonomic hazards from lifting, sitting, and repetitive tasks
- Latex
- Stress

This is not an exhaustive list, other risks can be involved.

OSHA:

There are protections set up with the Occupational Safety and Health Act (OSHA), This is particularly important within a healthcare environment. OSHA has a series of standards that protect the safety of healthcare workers and patients.

Program Responsibility:

Accredited medical assisting programs are required to teach students about the hazards that they face on the job and the protocols that can be put into place to ensure a workplace culture that prioritizes safety.

Admission Requirements Part II - Placement Testing

English/Math Proficiency:

Students are required to take ENG 111 in their first semester of the program and they must be eligible for MAT 110 - Placement in English and Math are based on various criteria:

- If a student graduated from high school less than 10 years ago (<10), we will use their High School GPA (See slide for High School GPA determination)
- If a student graduated from high school more than 10 years ago (>10), they will have to take a Placement Test
- SAT Reading & Writing score of 480 on each section
- ACT Reading score 22, English score 18
- Transferring college credits for English or Math with a grade of "C" or above

Eligibility for Eng 111 and Math 110, can affect progression in the program-

Admission Requirements High School GPA Determination

High School GPA	Placement	English Course Eligibility
≥ 2.8	Gateway English w/o Corequisite	ENG 111
2.2 - 2.79	Gateway English with Co- requisite	ENG 111 and ENG 011
< 2.2	Transition English	ENG 002 (CU) or BSP 4002 (ACR)



Pre-Medical Assisting Placement Testing Transition and Support Courses

Students who need transition or support courses for English and Math should complete these courses prior to enrolling in Medical Assisting Courses.

Please meet with an academic advisor to discuss placement test requirements and results.

- MAT 003-Transition Math
- CIS 110-Intro to Computers
- COM 231-Public Speaking

A 2.0 GPA must be maintained.

Medical Assisting Program Options

DAY PROGRAM

The ACC Medical Assisting program offers Daytime admission entry in the Fall (August) and Spring (January).

- Fall Starters can obtain a diploma in 3 semesters*
- Spring Starters can obtain a diploma in 4 semesters*
- All Students are encouraged to complete the Associates Degree which can be completed online as you work!

EVENING PROGRAM

We offer entry into our Evening program once a year (In August).

- Evening students can complete the diploma option in 5 semesters*
- All students are highly encouraged to complete the Associates degree, which can be completed online as you work!
- Evening students will have to be available during the day during the Clinical Experience (no exceptions)

* Progression in the program depends on Academic and Professional Guidelines

Admission Requirements Part III - Registration

- Watch your ACC Email for Advising and Registration Information
- Schedule an Appointment with a Medical Assisting Advisor or a Health Sciences Admissions Coordinator
- Know Your School ID when communicating with Advisors
- Be sure you understand your Financial Aid Guidelines (Advisors cannot advise or council you on Financial Aid requirements)
- Determine which Program Option is best for you (Day/Evening)
- Review Course offerings in the Course Catalog in Self-Service or on the Main Page (Filter to the correct semester to get the most accurate results)
- Order your books early to avoid delays and being unprepared for class Refrain from buying Used books Many of our courses require access codes that may not be available in Used books!
