Status of Coronavirus Emergency Financial Aid to Students (Federal Reporting) Higher Education Emergency Relief Funds, Coronavirus Aid, Relief, and Economic Security (CARES) Act, U.S. Department of Education As of August 18, 2020

• Alamance Community College (College) signed and returned to the Department of Education (Department) the College's Certification and Agreement for Emergency Financial Aid Grants to Students under the CARES Act. This includes assurance that the College has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

• The College was funded \$1,183,893 from the Department pursuant to the College's Certification of Agreement for Emergency Financial Aid Grants to Students.

• As of the date of this report, the College distributed \$1,183,893 to students.

• The estimated total number of the College's students eligible to participate in the programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 2,504.

• As of the date of this report, the total number of students who received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Acts is 1417.

• The methods used by the College to determine which students receive Emergency Financial Aid Grants, including how much a student would receive under Section 18004(a)(1) of the CARES Act have been determined. See Exhibit 1 for Phase 1 and Phase 2 distribution.

• Students who are eligible to receive an Emergency Financial Aid Grant received an email notification sent on May 4, May 11 (Exhibit 2 (a)) and June 30th (Exhibit 2 (b)) 2020 to their individual College email address. See Exhibit 2. The college also created a web page as well as posted the information on the college's social media sites on May 4th.

• Students who are eligible to receive an Emergency Financial Aid Grant were required to complete an online application to request funding in Phase 1. See Exhibit 3.

• Phase 2 emergency grants disbursements were distributed to all Title IV-eligible students enrolled during Spring 2020 semester in one or more on-campus or hybrid courses that converted to online delivery or completion was deferred to summer 2020 semester.

EXHIBIT 1

Alamance Community College Coronavirus Aid, Relief, and Economic Security (CARES) Act Federal Higher Education Emergency Relief Fund Emergency Financial Aid Grants to Students Eligibility Determination Guidelines

Phase 1 Distribution

• Student must have been enrolled in at least one face-to-face class during Spring 2020 semester when the state of emergency due to coronavirus was declared.

• Student must submit the Free Application for Federal Student Aid (FAFSA) and be deemed Title IV eligible as defined by Section 484 of the Higher Education Act. Eligibility criteria include the following: o Student is enrolled or accepted for enrollment in a degree or certificate program.

o Student has a high school diploma or GED.

o Student does not owe an overpayment on Title IV grants or loans.

o Student is not in default on a Title IV loan.

o Student, as part of the financial aid application process, filed a certification that includes a statement of educational purpose and social security number.

- o Student has a verified security number.
- o Student is a U.S. citizen, permanent resident, or eligible noncitizen.

o Student returned fraudulently obtained Title IV funds, if convicted of or pled guilty or no contest to charges.

o Student has not fraudulently received Title IV loans in excess of annual or aggregate limits.

o Student repaid Title IV loan amounts in excess of annual or aggregate limits if obtained inadvertently.

o Student registered with Selective Service, as applicable.

o Student does not have a federal or state conviction for drug possession or sale, with certain time limitations.

• Student must complete an online application by logging into student's individual student e-forms and submitting an application. As part of this process, student attests his/her need is related to the disruption of campus operations due to coronavirus and falls into an eligible category of expense.

• Awards range from \$100 to \$1,000.

Phase 2 Distribution

After July 6th, 2020, funds that remained available for HEERF/CARES student emergency grants were awarded to all Title IV-eligible Alamance Community College students (as defined by a completed 2019-2020 FAFSA) who were enrolled in one or more on-campus or hybrid courses on/after March 13, 2020. Those courses either converted to online delivery or completion was deferred to 2020SU, resulting in campus disruption and expense to students. Funds were allocated based on the number of on-campus or hybrid courses taken by each student, such that students who were enrolled for a heavier course load received a larger grant. The specific allocation to each student will be \$240 per class that qualifies. The Phase 2 allocation was expected to exhaust all remaining funds of the \$1,183,893 allocated to Alamance Community College specifically for student emergency grants.

A small amount of funds remained after Phase 2 distribution. The college awarded those funds to students that applied with the application in Phase 1 after the July 13th deadline. Awards based on application date. For applications that were on the same date, the college ranked students by EFC, awarding funds to those that were a lower EFC first until all funds were expended.
