

2020-2021 Parent Supplemental Nutrition Assistance Program (SNAP) Verification Form

Your student's 2020-2021 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we must ask you to confirm the information you reported on your student's FAFSA. To verify that the information is correct we will compare your FAFSA with the information on this institutional verification document and with any other required documents. If there are differences, your student's FAFSA information may need to be corrected. The parent whose information was reported on the FAFSA must complete and sign this institutional verification document, attach any required documents, and submit the form and other required documents to the Alamance Community College financial aid office. 1. Complete this section for the person in the student's household who received benefits from the Supplemental Nutrition Assistance Program or SNAP (formerly known as food stamps) any time during the 2018 or 2019 calendar years.

The student/parent received SNAP benefits in 2018 or 2019. If asked by the student's school, I will provide documentation of the receipt of SNAP benefits during 2018 and/or 2019.

The student certifies that a member of the student's household, received benefits from the Supplemental Nutrition Assistance Program or SNAP (formerly known as the Food Stamp Program) sometime during 2018 or 2019. NOTE: If we have reason to believe that the information regarding the receipt of SNAP benefits is inaccurate, we may require documentation from the agency that issued the SNAP benefits in 2018 or 2019.
