Witness our ongoing Minority Male Medical Bridge program, our computer camp for middle school female students, our engineering, manufacturing and biotechnology camps for all ages.

We continue to build relationships and forge partnerships with leaders in the life sciences and STEM arenas—this linked to growing our Biotechnology Center of Excellence. That Center, I believe, is critical to serving a burgeoning biotechnology corridor in central North Carolina.

This report also captures the rhythms of life at Alamance Community College: graduations, awards, VIP visits, efforts to ensure student success, and how we are empowering our graduates to compete in a 21st century economy.

I hope that as you review this report, you will take considerable pride in how Alamance Community College is putting our community front and center in the 21st century.

Dear Donors, Alumni, Faculty, Staff, Students,
Volunteers and Friends:

ACC Foundation celebrated a successful year as we continued to work hand-in-hand with you to create and maintain the resources required to prepare students for gainful employment in the 21st century.

More than \$1.5 million was raised during the 2018–2019 fiscal year with significant donations that included a \$1 million commitment from LabCorp for equipment for the Biotechnology Center of Excellence building; a \$217,000 grant from the Charles A. Cannon Charitable Trusts for ADA enhancements in current buildings; a \$97,500 grant from Duke Energy Foundation to develop a native prairie and access to the Haw River; and a \$94,000 donation from the Shallowford Community Development Club for an endowed scholarship. Additionally, the Foundation sponsored or facilitated programs for students of all ages for activities such as Engineering Camp, Ladies in Technology, Manufacturing Camp, and Medical Bridge. Other grants encouraged partnerships with the education community such as MechTech Institute, which prepares high school STEM (science, technology, engineering, mathematics) teachers to enhance their students' knowledge and interest in advanced manufacturing careers.

As Alamance County's population grows and diversifies, the need for investment in education increases. The November 2018 bond referendum to support Alamance-Burlington School System and ACC won overwhelming support from voters who see clearly the spectrum of educational needs in our community. The approved \$39.6 million bond referendum means ACC can move forward with critical projects including designing and constructing the Biotechnology Center of Excellence building—a flagship for biosciences training in our county and across the state.

As two-thirds of all ACC curriculum students require financial help to attend college, the ACC Foundation plays a fundamental role in meeting the need. During the 2018–2019 school year, the ACC Foundation provided more than 900 students with nearly \$600,000 in tuition assistance and other forms of aid.

The Foundation is grateful for the consistent and generous support of our donors. As a partner with you, we can continue to assure Alamance Community College's proven role as an economic engine in Alamance County by offering financial support and educational enrichment opportunities to our students.

Alamance County citizens gave the College in November 2018 approval to proceed with plans for capital improvements as 65 percent of all voters said “yes” to a \$39.6 million bond referendum.

“We are moving forward in a game-changing way now that we have passed the largest bond measure in the history of this College,” said ACC President Algje Gatewood.

Here’s what we can expect to see happening on the campus over the next few years:



Voters Approve \$39.6 Million Bond Package for ACC

Natural and Life Sciences/Biotechnology Center of Excellence and Expanded Parking for Students

- \$17.56 million (Center of Excellence building & additional student parking)
- 30,000 square feet of new construction (including new Center of Excellence in partnership with local/regional business and industry and non-profits)
- 10,000 square feet of renovation to existing Health Sciences facility
- Center of Excellence will include 8 labs, 3 classrooms, 1 greenhouse, 1 office suite, and additional event space
- Added surface parking prepares for projected 16 percent enrollment growth by 2024

Public Safety Training Center

\$1 Million LabCorp Gift Equips Biotech and Life Science Programs

The College last year was the beneficiary of a \$1 million gift from LabCorp, Inc. that will be used to provide students and instructors in Biotechnology, Medical Laboratory Technology (MLT), Histotechnology, and Agricultural-Biotechnology programs with state-of-the-art laboratory equipment and supplies.

While the gift has already resulted in new equipment for the MLT program, the College will use the largest portion to outfit ACC's Center of Excellence facility, a planned 30,000 square-foot facility approved by voters in 2018 as part of the \$39.6 million bond resolution.

The partnership between LabCorp and ACC spans several decades, including the College's Biotechnology program in 1985, a Medical Laboratory Technology program in 1988, and a new Histotechnology program in 2018. These programs help prepare students for sustainable, successful careers, reflecting the collaborative approach that benefits students, employers and the broader community.



ACC Becomes Siemens PLM Software Academic Program Partner

Siemens PLM Software gifted the College software that gives 175 students access to the same technology that companies utilize every day in a variety of industries including automotive, machinery, and high-tech electronics.

The software for Alamance Community College includes:

- Solid Edge™ software, an intuitive development platform for accelerating all aspects of product creation, including 3D design, simulation, visualization, manufacturing, and design management
- NX® software, a leading integrated solution for computer-aided design, manufacturing and engineering
- Tecnomatix® portfolio, the industry-leading digital manufacturing software

UNC Wilmington Agreement Gives Graduates Guaranteed Admission

ACC students were provided a new educational avenue with the signing last spring of an agreement that guarantees enrollment at the University of North Carolina at Wilmington.

The core values of the Pathway to Excellence Agreement are multi-layered:

- Guaranteed admission to UNCW for ACC students completing an Associate of Arts, Associate of Science, Associate of Engineering, Associate of Fine Arts in Visual Arts, Associate of Fine Arts in Music
- UNCW will provide a Transfer Student Success Advisor to meet with students at ACC at intervals throughout each semester.

UNCW Transfer Merit Scholarship

ACC students graduating with an Associate of Arts or Associate of Science are eligible for the UNCW Transfer Merit Scholarship. Scholarships are one-year awards ranging between \$1,500 and \$3,000.

The Pathway to Excellence Program with UNCW is the latest transfer agreement that ACC has partnered with other North Carolina institutions of higher learning. Other partnerships of recent years include those with NC State, NC Central, UNCG, and Elon University.

\$100,000 NC Biotech Grant Helps College Prepare Local Talent for New Jobs

The College was the recipient in fall 2018 of a \$100,000 Economic Development Award (EDA) from the North Carolina Biotechnology Center that promises to boost bioscience industry growth in Burlington and Alamance County.

The grant, administered by the City of Burlington, is being used to help the College prepare local talent for new jobs created by LabCorp, Inc.

Burlington's EDA will be used to develop the job-training capacity at Alamance Community College, tailored to the needs of LabCorp but relevant to other life science employers as well.

Burlington/Alamance County is No. 1 in the nation for small metropolitan statistical areas in research, testing and medical labs, according to a 2016 report on the impact of life sciences on North Carolina by TEconomy Partners, a research, analysis and strategy consultancy for economic development. Bioscience employment in Alamance County is forecasted to grow by 7 percent from 2017 to 2020.

Governor Touts Student Assistance Program

N.C. Governor Roy Cooper made a stop at the College in January 2019 to conduct a roundtable discussion with students who have benefited from Finish Line Grants, a program that helps community college students who face unforeseen financial emergencies to complete their training.

ACC was among the first community colleges to kick off its Finish Line Grants program in fall 2018. Currently 63 students have been helped and nearly \$59,986 awarded.

Bills submitted for payment may include automobile repairs or insurance, utility bills, unexpected medical bills, childcare expenses, and course materials. Each student recipient is limited to \$1,000 per semester and must have completed at least 50% of their degree or credential program.

Brian Barringer coordinates the Finish Line Grants program at ACC, assisted by staff in the Student Success Office and Business Office. The College has partnered with the Workforce Development Board and Workforce Innovation and Opportunity Act staff to establish a joint process for reviewing and awarding funding requests from students.

Governor Cooper held court at a roundtable conversation with five ACC students, three of whom benefited financially from the Finish Line Grants program.

Both Governor Cooper and NC Community College System President Peter Hans praised the leadership at ACC for helping students stay in school. Student retention and completion are vital to this College's workforce development mission.

ACC to Use State Grant for Workforce and Apprenticeship Initiatives

Alamance County and three nearby counties shared a portion of a \$3.2 million Eastern Triad Workforce Initiative Grant last year to support ACC's apprenticeships and on-the-job training initiatives. The effort is aligned with Governor Cooper's NC Job Ready strategy.

The College is using its share of the funds to support:

In-School Youth and K-12 school system:

- Hire a program administrator to oversee recruitment/awareness efforts
- Produce a National Apprenticeship Day event
- Provide assistance to employers to cover a portion of the cost of books, fees, and equipment for apprentices
- Provide Career Explorer kits for 9-12 grade students

Out-of-School Youth and Adults:

- Provide on the job training supplements
- Provide Incumbent Worker Training for Upskilling

A NCWorks survey of North Carolina employers found that 50 percent of employers who tried to hire last year had difficulty filling at least one position. Just over half cited applicants' lack of relative work experience, while just under half said that their hiring difficulty stemmed from job seekers' lack of technical or occupation-related skills.

Nearly 1500 students received an eye-opening experience last February during the Alamance-Burlington Schools System (ABSS) 8th Grade Tour Extravaganza on the College campus. Faculty conducted hands-on mini-tours of their departments, giving the young students opportunities to touch a pig's heart, watch physics in action, taste Culinary-baked cookies, hold a snake, perform CPR on a "breathing" computerized mannequin, and much, much more. ACC and ABSS partnered on the successful event to address one of the College's key strategic initiatives: "Strengthen outreach to community partners to improve resource development and educational opportunities for Alamance County residents."

While in Raleigh, ACC leaders visited the offices of local county representatives, including Rep. Dennis Riddell, Senator Rick Gunn, and Rep. Stephen Ross.

ACC leaders also met with the local legislative delegation last winter on the college campus to review the N.C. Community College System's 2019 Legislative Agenda. Community college leaders asked the General Assembly for additional investments in programs and technology that foster workforce development.

President, Trustees Make Splash at NCACCT Conference

College President Algie Gatewood, accompanied by six ACC trustees, made a presentation on ACC's popular Career Accelerator Program (CAP) at last summer's North Carolina Association of Community College Trustees (NCACCT) 2019 Leadership Seminar in Wilmington.

Before an audience of community college trustees from across North Carolina, President Gatewood described the CAP apprenticeship partnerships ACC enjoys with local companies AKG, ECI (Engineered Controls International LLC), Fairystone Fabrics, GKN Driveline, Glen Raven, Indulor America LP, Jabil Packaging Solutions, Sandvik Coromant, Shawmut Advanced Materials, and Intrapac. He mentioned other key partners ABSS (school board, counselors, teachers) and the Alamance Chamber of Commerce. Dr. Gatewood told the attendees that "CAP is perhaps the most visible intersection of education, workforce training and economic development. This learn and earn apprenticeship program is directly aimed at bridging the skills gap in advanced manufacturing."

ACC's apprenticeship program began with five students and has increased to 39. CAP initially began linked only to the Mechatronics Engineering Technology program, but is now expanding to Computer-Integrated Machining and Industrial Systems Technology.

Summer Camps Help Bridge Skills Gap to Area Youth

With a dramatic focus on changing the belief/interest gap among young people, the College coordinated a variety of enrichment opportunities in summer 2019 to bridge the skills gap that exists in today's workforce.

Because women and minorities are under-represented in STEM (science, technology, engineering, and math) fields, ACC also believes in serving those under-represented populations and introducing young students to career possibilities.

Minority Male Medical Bridge Camp

For the third consecutive summer, the College hosted dozens of minority male 6th-8th graders for the Medical Bridge Summer Camp—a three-week intensive immersion into math, science and writing programs that lays the groundwork for success in medical and STEM careers.

Partnering with the Alamance-Burlington School System and the UNC School of Medicine, ACC facilitated the camp to address the gross under-representation of minority men in medical fields.

Said coordinator Lakeisha Vance: “Students complete interactive science labs and STEM activities using comprehensive curricula from Carolina Biological. Students interact with minority male mentors in medicine and science who encourage and prepare students for the future. We visit colleges, businesses, and medicine-related organizations so students can see the impact they can make in these areas.”

The College aims to seamlessly transition these students from middle school to high school to an ACC degree and on to a four-year university to continue their education.

Engineering Camp—Elementary Students

ACC and Alamance-Burlington Schools (ABSS) collaborated on the inaugural Alamance Engineering Camp, which introduced STEM education to 19 rising 3rd-5th graders.

Boys and girls learned engineering methodology through trial and error hands-on projects taught by specially-trained ABSS faculty.

Manufacturing Camp—Middle & High School Students

Middle and high school students, in alternating weeks, immersed themselves in all things industrial for the first-ever Manufacturing and Skills Trades Camp held in ACC's Advanced Applied Technology Center (AATC).

The College initiated the camp to expose students to programs in the Industrial Technologies division. Each department introduced the students to a hands-on project, such as plasma cutting in welding, making a Yo-Yo in machining, and drawing a house plan in drafting. Seven of the 19 students were young women.

BioAcademy

Twelve ABSS high school students delved into advanced biotechnology studies for the fourth annual BioAcademy held in ACC's biotechnology department.

Funded by a National Science Foundation grant, the camp gave the students an opportunity to work with animal stem cells, their own human DNA, and methods of biofuel production while learning advanced processes in the biotechnology field.

The College's Biotechnology program is the longest-running two-year program of its kind in the United States. Michelle Sabaoun is department head.

'Ladies In Technology' Camp

Each summer since 2017, ACC has operated a Ladies in Technology camp for rising sixth through tenth grade girls to broaden interest in technical careers for women. The theme this year was web development and responsible online privacy/security best practices.

"We wanted to inform these young ladies of their ability to make an impact by effectively utilizing technology to share a positive message," said Lakeisha Vance, camp coordinator.

ACC's Ladies in Technology program developed as a result of research that reported approximately 1.4 million computer-related jobs will be unfilled by 2020.

THIS YEAR AT ACC



The College hosted multiple county agencies from law enforcement and emergency services during several drills this summer. A tabletop exercise with ACC and county agencies on August 7 provided ACC personnel with an opportunity to discover proper procedures in conjunction with county agencies.

College Held Emergency Preparedness Drills

The College hosted eight emergency preparedness exercises for first responders from May through August 2019. The training exercises allowed ACC to align its Emergency Management Plan with first responders so that agencies can test how well they respond to emergencies within a campus community.

More than 350 law enforcement and emergency personnel participated in the exercises last summer.

The training exercises were evaluated by EnviroSafe of Burlington, the company that has developed the College's Emergency Operation Plan.



ACC Hosts Annual 'State of Alamance' Panel Discussion

The College hosted the largest crowd yet for the annual State of Alamance panel discussion in August 2019.

Sponsored by the Triad Business Journal, the event kicked off with a keynote address from Allen Gant Jr., chairman of Glen Raven Inc., who told the VIP audience what it takes for Alamance County to be competitive not just in the next few years but for decades to come.

A business panel discussed keys to preparing a talented, sustainable and innovative workforce for the future. Career Accelerator Program Introduces 4th Apprenticeship Cohort

Since 2016, the College has partnered with Alamance-Burlington Schools and the NC Department of Commerce to support the Career Accelerator Program (CAP) – a win-win initiative that helps high school students and recent ACC graduates earn certifications and get paid on-the-job training.

In August 2019, the fourth CAP cohort of 10 newly christened apprentices signed contracts with eight local manufacturing companies.

Over the next four years, each of these 10 high school seniors and recent graduates will earn free Associate in Applied Science degrees from ACC, Journeyman Certificates from the NC Department of Commerce, and paid on-the-job training.

The formation of CAP is based on some key and troubling statistics:

- Industrial workforce is aging, and it is an imperative to replace those workers. Every day, 10,000 baby boomers will reach retirement age for the next 19 years. That's 3.65 million per year.
- By 2030, the U.S. could experience unrealized revenue of \$1.74 trillion due to labor shortages from attrition, retiring workers, and other factors. That's 6% of the entire economy.
- By 2020, 67% of jobs in North Carolina are projected to require postsecondary education. Yet only an estimated 48% of adults between 18 and 64 had a degree or credential to meet the skills requirement in this state.

'Draft Day' Brings Industrial Students, Employers Together on Campus

In spring 2019, the College hosted *Draft Day*—an outgrowth of listening sessions organized by the Industrial Technologies division earlier in the year.

The special event was aimed at building stronger connections with local industry while providing students a comfortable venue to learn more about businesses and employment opportunities available to them in one-on-one contacts.

SkillsUSA Competition Awards ACC Students in Welding, IT, Cosmetology

Alamance Community College took a lead role in last spring's SkillsUSA North Carolina Conference competitions, hosting the welding contest on the Haw River campus.

SkillsUSA is a national organization that provides educational programs, events and competitions that support career and technical education (CTE) in the nation's classrooms. ACC hosted 23 student welding teams representing 17 colleges and 8 high schools from across North Carolina. The contest in the College's Advanced Applied Technology Center (AATC) pitted 69 students—including a 3-person ACC student team—in a timed event in which competitors used their welding skills to construct a project while seeing the blueprints for the very first time. The ACC student welding team placed 3rd in the Skills USA Postsecondary Welding Fabrication Competition.

In other SkillsUSA competitions held in Greensboro, ACC Information Technology students came away with a pair of second place awards.

Cosmetology students earned 7 awards.

ACC was recognized at the awards ceremony as one of the top 10 schools for membership growth this year.

Students Place in Top Ten at Nationals

ACC students Alannah Smith and Keandra Walker ranked in the top 10 for the SkillsUSA national championship competition in Web Design.

The SkillsUSA National Championships, held in Louisville, KY last summer, were the centerpiece of the 55th SkillsUSA National Leadership and Skills Conference, a showcase of career and technical education students.

Alannah and Keandra, representing North Carolina at the national competition, are both pursuing associate degrees in ACC's Information Technology program. Their team placed 8th overall.

The Web Design contest evaluated teams as they completed a series of challenges focusing on website usability and accessibility, with at least one challenge related to scripting. Each challenge had to be documented, clearly demonstrating the skills as outlined in the SkillsUSA Championships Technical Standards.

For the 16th straight year, Horticulture Technology students competed at the National Collegiate Landscape Competition at Colorado State University.

In competitive events against hundreds of other students, ACC finished 16th place overall out of 64 colleges and universities from across the U.S.

ACC Horticulture Technology student Dillon Terwilliger placed fourth in the nation among all 788 participating students, based on his total competition points.

The weeklong event provided all students an opportunity to participate in workshops, a career fair, and 29 different competitive events that directly pertain to the horticulture industry.

ACC Students Win Awards at 16th Straight National Landscape Competition

Science Olympiad at ACC

The College welcomed nearly 500 elementary students to its campus last April as they competed in a variety of contests for the NC Science Olympiad. The purpose of the annual event is to attract young people toward science, technology, engineering, and mathematics (STEM) degrees and careers in North Carolina. The College's science and math departments additionally provided hands-on STEM activities for families with young children during the Olympiad. Those activities focused on engineering, robotics and life sciences.

College's Medical Lab Tech Program Celebrates 30 Years

ACC celebrated the 30th anniversary of its Medical Laboratory Technology (MLT) program in 2018.

Begun in 1988, Medical Laboratory Technology was created when Elon College (now University) opted to end its MLT program that offered an Associate in Applied Science degree. Roche Biomedical's (now LabCorp) leadership needed a pipeline of laboratory talent to keep up with the company's high growth rate, and partnered with ACC to develop the new program. It filled the gap to prepare students to perform clinical laboratory procedures that help diagnose and treat disease, as well as help maintain health.

"With 416 graduates since its inception, our MLT alumni work in leading diagnostic labs, clinics, healthcare companies, and hospitals across the U.S.," said Dr. Bridget Ledford-Waters, MLT Department Head.

The College has partnered for many years with clinical affiliates such as Duke, UNC, Cone Health, and LabCorp, where MLT students spend much of their clinical time honing their laboratory skills with highly specialized procedures and diagnostic equipment.

Renovated Student Center

ACC Awards 912 Graduates at Commencement

The College awarded a total of 912 graduates with associate degrees, diplomas and certificates in summer 2019 during a commencement ceremony held on the Elon University campus.

The ceremony honored two groups of graduates: 709 earning traditional degrees and certificates in curriculum programs, 149 earning High School Equivalency (GED, HiSET) and 54 earning Adult High School diplomas.

A total of 135 Alamance County high school students earned college credit credentials through Career and College Promise. CCP allows qualified high school students to take community college courses for free, following a specific pathway that can lead to college credits, certificates, and the Associate in Arts and/or Associate in Science degrees that are transferable to four-year institutions.

Among those CCP graduates were 60 high school students earning Associate in Arts degrees with 60 or more college credits, allowing them to transfer with full junior class status. Completing 26 or more college credits, equal to a full year of college, were 19 high school students following the University Transfer Pathway. Earning certificates or diplomas in various career technical programs were 79 ABSS high school students.

ACC Faculty Promote Enrollment Via Link Transit

College and local government officials hit the highway in early summer to drum up student enrollment for the fall 2019 semester.

College faculty, administrators, and county officials took advantage of the Link transit buses' Free Fare Week by riding the public transportation to reach potential students where they work and live.

The "Get Loud for Literacy and Learning" bus rides and festival featured Continuing Education, Academic and Career Readiness, and Curriculum faculty riding Link Transit buses to distribute information along the route from Alamance Community College to North Park.

The event graphically illustrated the feasibility of using buses to attend ACC classes at the Jimmie Kerr and Dillingham campuses, while also reaching a large audience of potential students.

ACC President Algie Gatewood kicked off the festival when he joined ACC personnel by hopping aboard a special Link Transit bus at the College. ACC personnel distributed free books provided by local company Alamance Foods at the Link Transit Hub in Burlington.



\$40,000 United Way Grant Helps Literacy Students

The College's Academic and Career Readiness division, which has received United Way grants for the past five consecutive years, was awarded one of Alamance County's largest for \$40,000.

This grant provides Academic and Career Readiness with:

- GED and HiSET practice and official test vouchers for any ACC student who resides in Alamance County, resulting in more high school graduates and students transitioning to workforce and curriculum programs.
- All testing vouchers for Alamance County Detention Center students. As of early fall 2019, ACC had graduated 9 students in this program.
- Distress funds for gas, Link Transit bus passes, and books; a part-time Literacy Specialist who teaches at May Memorial Library in downtown Burlington and who recruits at events, library branches, and The Salvation Army.
- ACC's annual Resource Fair that connects students to needed community service agencies.

The grant helps support ACC's partnership with Women United, a select group of women who give of their time and resources to act as mentors. Throughout 2019 ACC supported a group that mentored bilingual cosmetology students in their ESOL/Civics class. Almost 40 students were enrolled in a Friday night class as of summer 2019.

Career and College Promise (CCP) Continues Its Expansion

Career and College Promise provides a tremendous opportunity for high school students to get a jump start on their college education, without paying tuition. The added benefit is that these courses count toward high school graduation, so students are not taking additional classes on top of high school requirements.

- The growth in the College's CCP enrollment is due in large part to ACC's strong partnerships with Alamance-Burlington Schools System (ABSS), and charter and private schools in the county. ACC sends its own instructors to 11 different high schools to deliver college curriculum on their campuses.
- The number of CCP students at the College has increased every year since the program began in 2012. Student enrollment has doubled over the past 5 years. In Fall 2015 ACC had approximately 600 high school students taking free college credit courses, and Fall 2019 approximately 1200 high school students were enrolled.
- As of Fall 2019, the CCP program comprises 27% of the College's total enrollment.



HR Professionals Earn Certifications. ACC's Office of Corporate Education and Economic Development teamed up with The Alamance County Human Resources Association (ACHRA) and the Human Resource Management Association of Greensboro (HRMAG) to certify over 75 HR Professionals within the Piedmont Triad area with their Lean Six Sigma White Belt Certification.

Business and Industry Training

Corporate Education provides the business and industry base of Alamance County with a variety of options to satisfy their training goals.

In Fiscal Year 2019 the State of North Carolina approved the Office of Corporate Education with the ability to facilitate over \$1.4 million of customized training projects in Alamance County.

- Leadership, Soft Skills, Industry Maintenance & Fundamentals, Safety, and Computer Training

ACC is the ONLY Community College in the state to offer certificate programs in partnership with top universities:

- **Lean Six Sigma** Process Improvement, White and Yellow Belts, and NC State University-linked Green and Black Belts
- **Supply Chain Engineering and Logistics** Bronze, Silver, and Gold Belts— University of Tennessee, Knoxville
- **Project Management Professional (PMP) Certification**

ACC Hosts 39 Minority and Women Business Owners for Symposium

Thirty-nine area business owners came to the ACC campus in spring 2019 for a free event aimed at helping minority and women entrepreneurs increase exposure for their businesses.

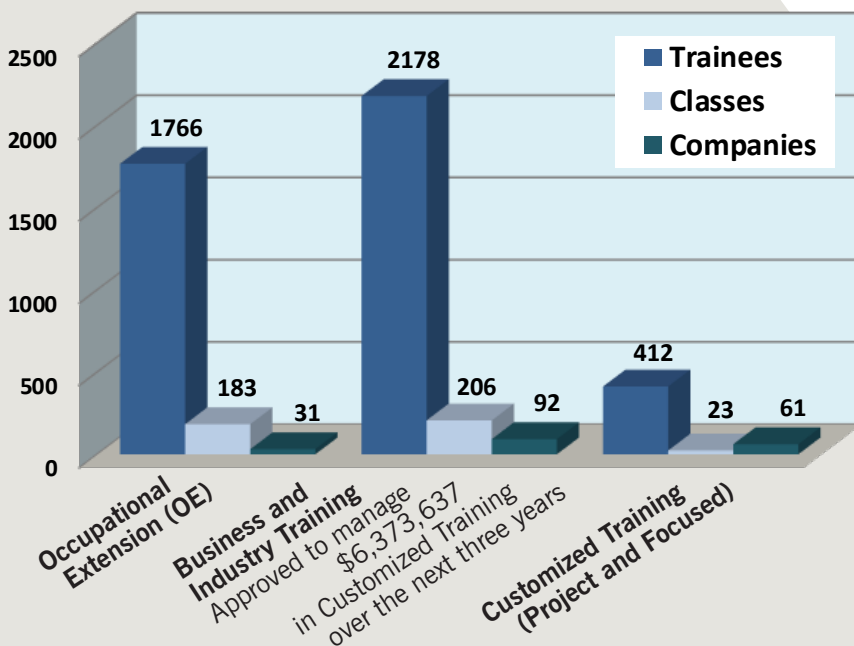
The event was sponsored by ACC's Small Business Center and the state-operated Minority and Women-owned Business Enterprise (MWBE).

Online – 26% • Hybrid – 1% • Web – 6%

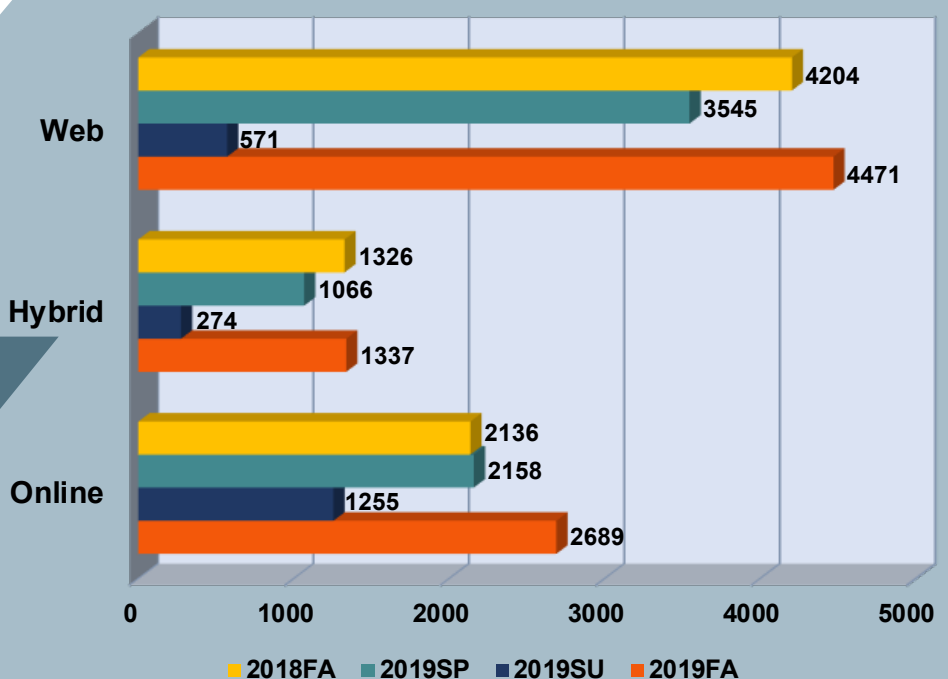
Fully Online Programs Developed

A financial supporter of the College for 35 years, Laboratory Corporation of America, Inc. (LabCorp) is the College's first repeat winner of this award.

At least 100 ACC graduates currently work at LabCorp and hundreds more have benefitted from ongoing training provided by the College. LabCorp helped ACC launch its new Histotechnology program, the scientific discipline that studies organs and tissues of the body. LabCorp provides volunteers throughout the College, including for the Medical Lab Technology (MLT) advisory committee. Last year LabCorp helped establish and expand critical MLT clinical rotation areas.

In addition to 35 consecutive years of donations to the ACC Foundation totaling millions for everything from student scholarships to equipment for its lab based programs, LabCorp will play an important role in the development of the new Biotechnology Center of Excellence facility that will be constructed through recently approved education bond for ACC.

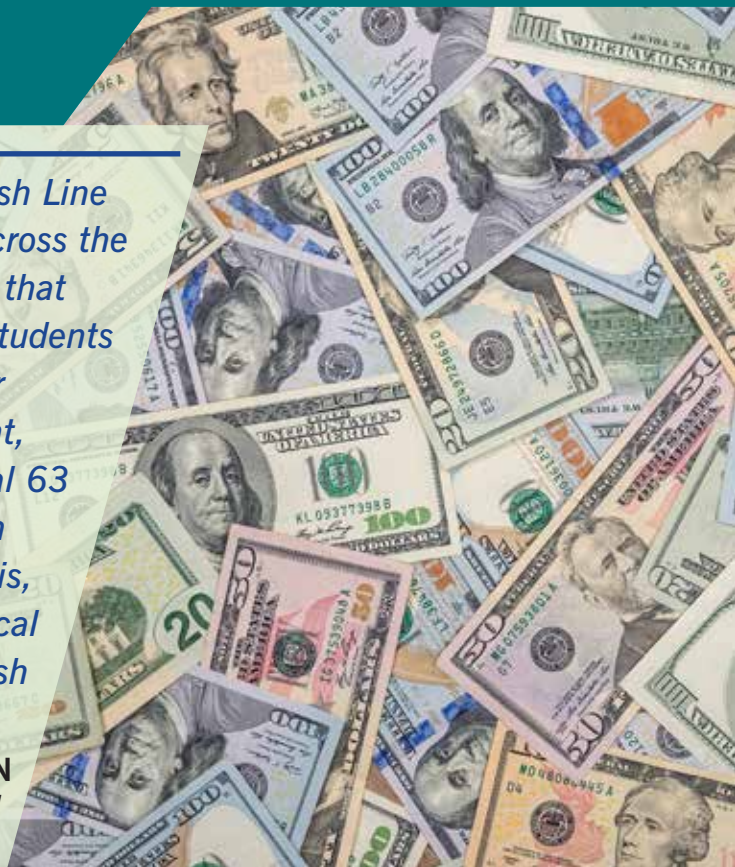

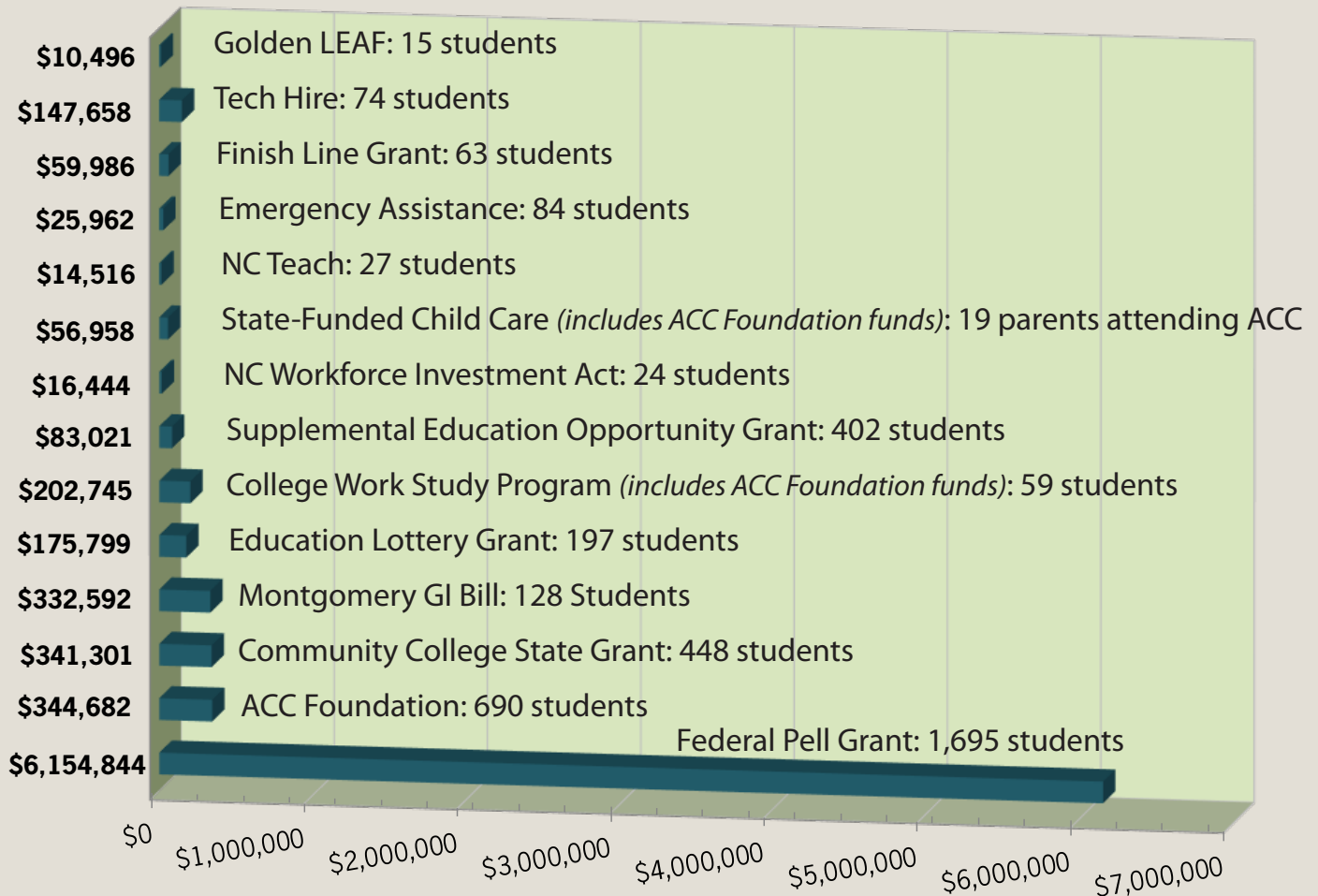

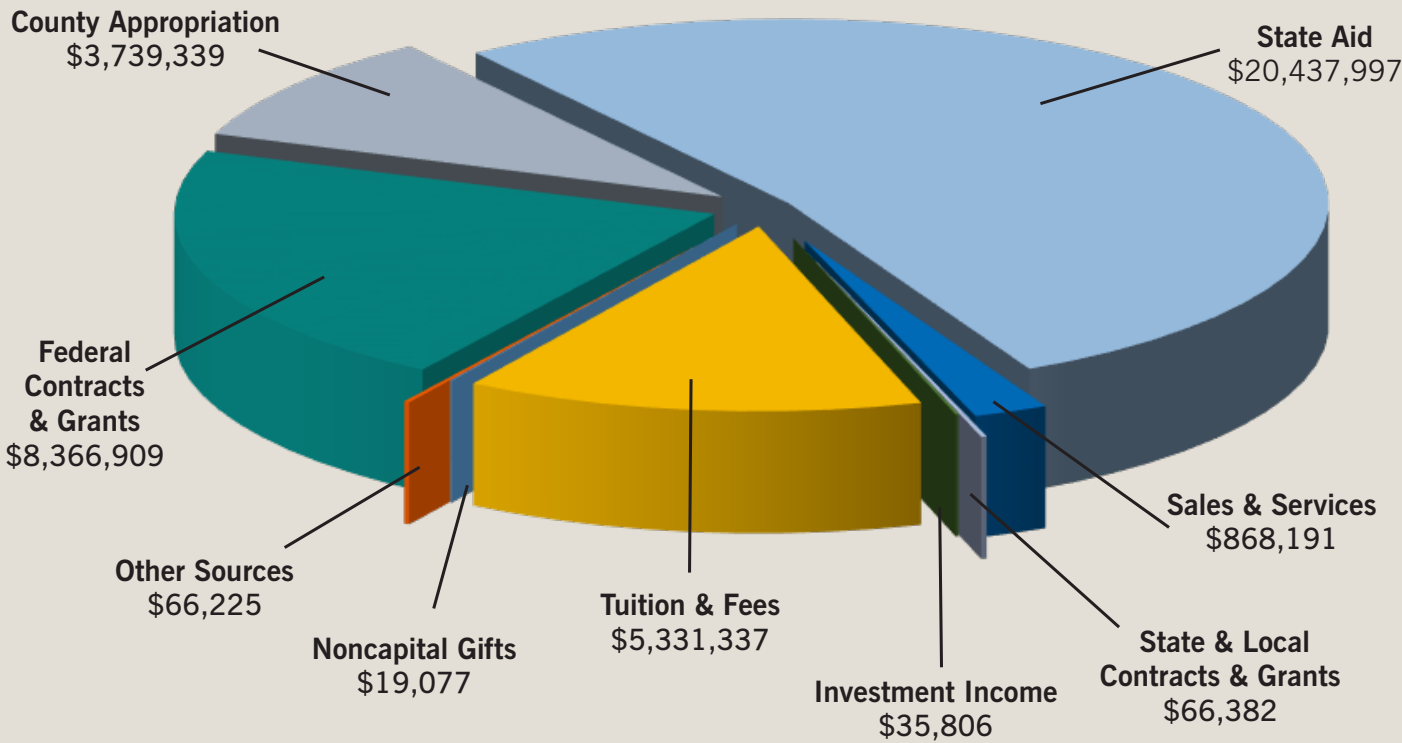


Selected Financial Aid Programs

Total/All Financial Aid: **\$8,189,846.64**—4,120 students helped *(duplicated)*

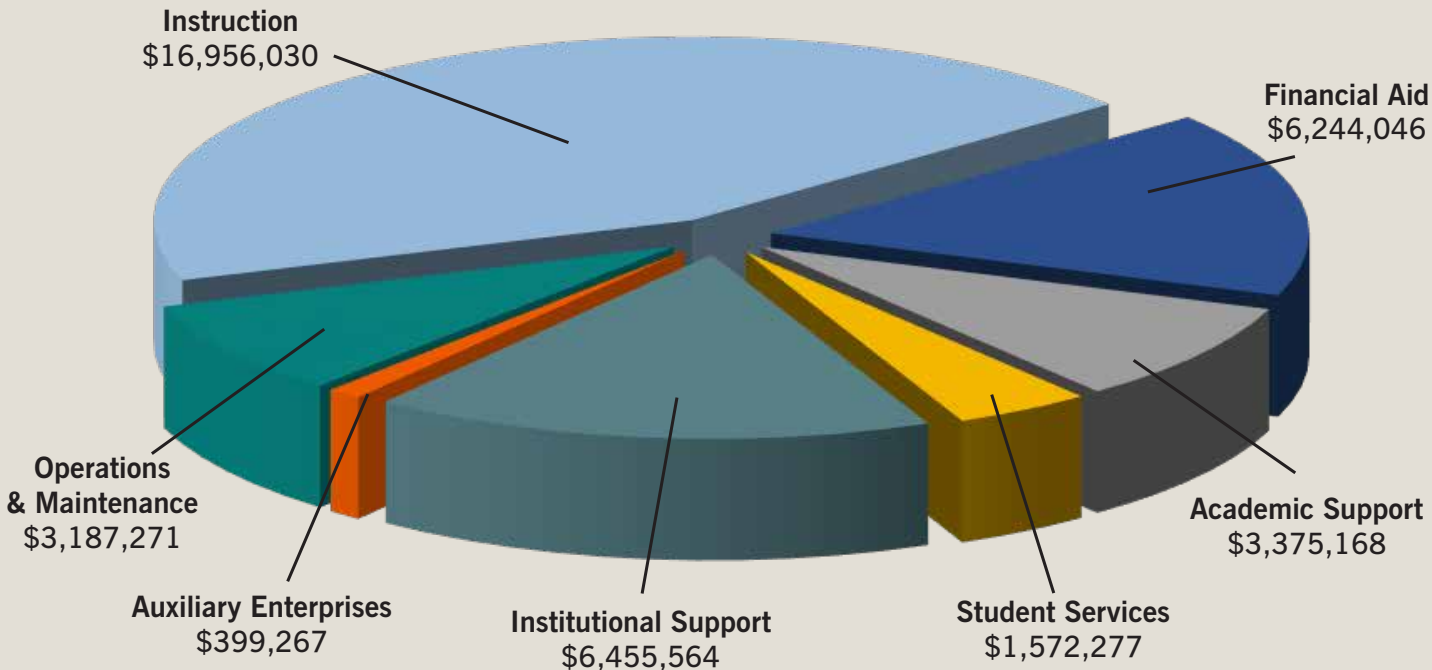


Current Fund Revenues: \$38,931,263*

Hard Work Made the Difference for ACC Alum

For someone who dropped out of high school and worked fast food jobs for two years afterward, Dylan Shaver has carved a career path for himself that a decade ago he probably could not envision.

Dylan has moved into a leadership role at his employer, Sandvik Coromant in Mebane.

He is a mentor to Career Accelerator Program (CAP) high school apprentices who are earning valuable work experience and college credentials.

Although Dylan dropped out of high school, he quickly earned his GED at ACC. Unfortunately his excitement to be out in the work world fell flat. After the 2009 economic downturn, he found himself at loose ends.

It was a turning point. Dylan took a long, hard look at his life goals, applied himself, and landed as a contract worker at Sandvik. His supervisor advised him to study in ACC's Industrial Systems (IS) program. Dylan took night classes while working fulltime.

Over time, his new schedule consisted of getting off third shift at 7:30 a.m., then on to his first class at ACC by 8 a.m. He did this for the next two years, completing his Associate in Applied Science in Industrial Systems degree in 2014. Today Dylan is the Lead Maintenance Technician at Sandvik.



ACC Student Makes Plans for Top MBA School

Savinna Mangalindan of Hillsborough, a 2019 ACC graduate, began pursuing her MBA degree this fall at the University of North Carolina's Kenan-Flagler Business School—an institution that is ranked as one of the country's best business schools.

Savinna, a native of the Philippines, moved with her family to North Carolina at age 16 and became a high achieving student. To curb costs, she opted to enroll at Alamance Community College and participate in the popular CSTEP program, which paved the way to transfer to UNC and the competitive Kenan-Flagler Business School.

CSTEP, or Carolina Student Transfer Excellence Program, guarantees admission to UNC Chapel Hill for qualified community college students, with the stipulation that they participate in required activities and events both at ACC and at UNC.

Savinna becomes ACC's first CSTEP student to be accepted for admission to UNC's Kenan-Flagler Business School.

Savinna bolstered her acceptance to Kenan-Flagler by taking advantage of leadership opportunities while at ACC, including her election as SGA president and by joining the NC Comprehensive Community College Student Government Association (NC4SGA). Her leadership this year earned her The Bryan Pugh Award at NC4SGA state convention.

When Savinna earned her Associate in Arts degree last summer, she knew the road toward her career ambitions was just beginning.



CCP Graduate Accepted to Duke University

Jachin Friday, a spring 2019 ACC graduate, was accepted to Duke University for the fall semester. Alamance Community College has no record of the last time one of its graduates enrolled at the prestigious Durham institution.

But Jachin beat those odds with his enrollment in Duke's Trinity College of Arts and Sciences where he will major in economics and mathematics.

His journey to Duke began when his family learned of a too-hard-to-resist opportunity offered at Alamance Community College—the Career and College Promise (CCP) program that offers high school juniors and seniors an opportunity to take free college credit classes while still earning their high school diploma.

Jachin took rigorous CCP courses at ACC that included Calculus I, II, and III, physics and microeconomics, and critical thinking. He was accepted into ACC's Honors Cohort program, founded an Economics Club, and joined the Math Club.

Jachin and his father, Shad Friday, are convinced that the availability of challenging classes at ACC contributed to the acceptance at Duke. Jachin's ambition is to pursue a career in data or financial management. But he knows his tenure at Duke University may open him to new opportunities and interests.

Foundation Receives \$217,000 ADA Grant

The ACC Foundation was awarded in spring 2019 a \$217,000 grant from The Charles A. Cannon Charitable Trust for Americans with Disabilities (ADA) compliance.

The funding goes toward ensuring ADA compliance across numerous renovation projects including accessible restrooms, ramps and fire doors.

\$97,500 Duke Energy Grant Will Benefit Haw River and ACC Students

As a result of a grant request by the Foundation, the College received a \$97,500 grant to continue its commitment to protecting and enhancing regional waterways and the environment. The grant is part of the Water Resources Fund, a \$10 million commitment from Duke Energy.

The Haw River and Native Prairie Demonstration Site project will improve water quality in the Cape Fear River basin, provide enhanced wildlife habitat, expand public access to the Haw River, serve as a river buffer model for community members, and provide educational opportunities for community college and high school students.

Mini-Grant Supports Youth Writing Camps



Writing creatively and accurately was the theme for summer writing camps that brought dozens of Alamance County children to the College campus. The summer writing camps were financially supported by an ACC Foundation mini-grant.

Divided into three age groups—rising 4th-5th, rising 6th-8th, and rising 9th-12th—the free camps were operated by Piedmont Voices, a Triad chapter of the National Writing Project. ACC was named a National Writing Project site in 2017 through the efforts of ACC English Instructor Courtney Doi, who acted as coordinator for the summer camps.

“Each group learned about different types of creative writing, engaged in writing exercises, learned how to give constructive feedback, and composed a polished piece for presentation,” said Doi.

The goal of the camp is to emphasize and develop writing skills in fun ways for the Alamance-Burlington school students, who will use writing in some fashion no matter what career they choose.



Middle school students got creative with their group “mummy” creations, a fun activity that tasked them with writing a story on how one student “became” a mummy, then illustrating the tale by wrapping a camper in donated toilet paper. Stories were judged by a staff member based on creativity and originality.



Girls Take Over Tech 2019

Girls Take Over Tech 2019 brought young women to ACC's Advanced Applied Technology Center (AATC) to encourage them to enter STEM fields that can lead to industrial careers. The open house in early January gave the middle and high school students an opportunity to participate in demonstrations in the fields of Welding Technology, Computer-Integrated Machining, Mechatronics Engineering Technology, Heating and Air, and Automotive Systems Technology. The College's Advancement Office coordinated the National Science Foundation-funded event.



ACC Scholarship Offers New Students 'Rebate' Classes

The ACC Foundation partnered with an anonymous donor last year to improve two-year completion rates for associate degree programs at the College through the establishment of a new Retention Scholarship.

The donor offered \$6,000, to be matched by the ACC Foundation, for students to rebate two classes (valued at \$466) upon the completion of an associate degree from fall 2018 to spring 2020. Up to 25 students will receive the rebate, based on completion of a two-year degree, financial need and the order in which they completed the application form.

New students with financial aid are given first priority, as well as the order in which they complete their credentials. The College will distribute awards until the \$12,000 is reached.

As of August 2019, Financial Aid had awarded 17 Retention Scholarships at \$233 each for a total of \$3,961.

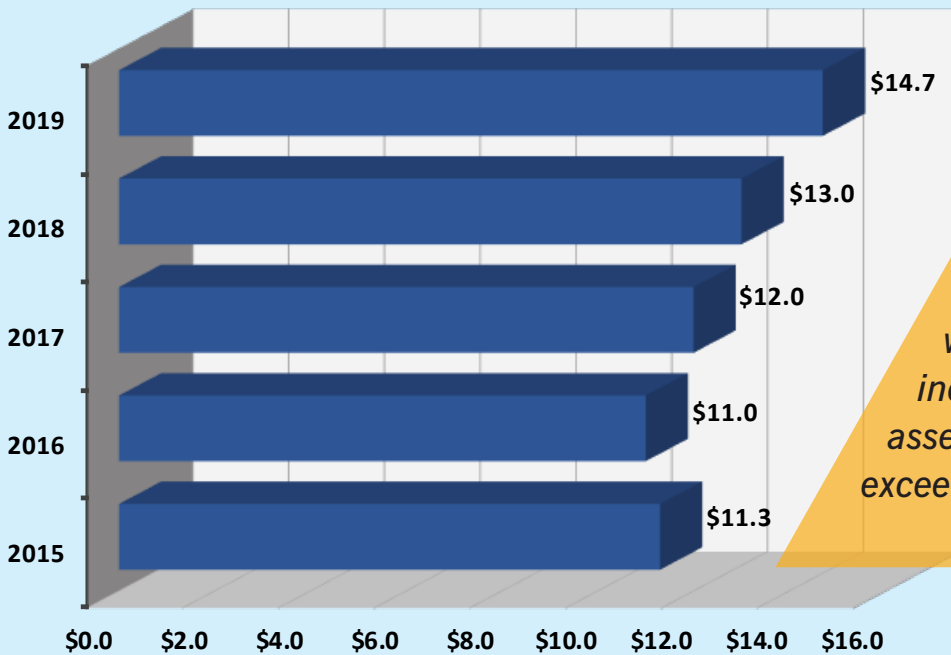

Value

As of June 30, 2019, the ACC Foundation's endowment was comprised of over 140 individual funds. Total financial assets of the ACC Foundation exceeded \$14.6 million.

Management

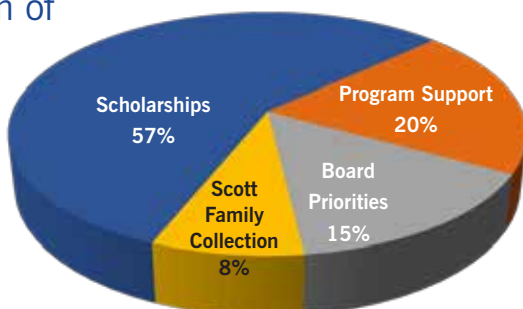
The ACC Foundation's financial assets are overseen by an Investment Committee consisting of ten volunteer business professionals. The Investment Committee establishes policies for the management of the assets and employs Trust Company of the South to carry out day-to-day investment activities.

The fund return, for the year ending June 30, 2019, was 2.99%.

Spending

The ACC Foundation employs spending and investment policies designed to provide a stable flow of support for the needs of ACC students and ACC educational programs, while preserving the future purchasing power of the endowment. The spending rate for the endowment assets is currently up to 5% of the average value of each fund over the previous 12 quarters, unless otherwise specified in the donor agreement.

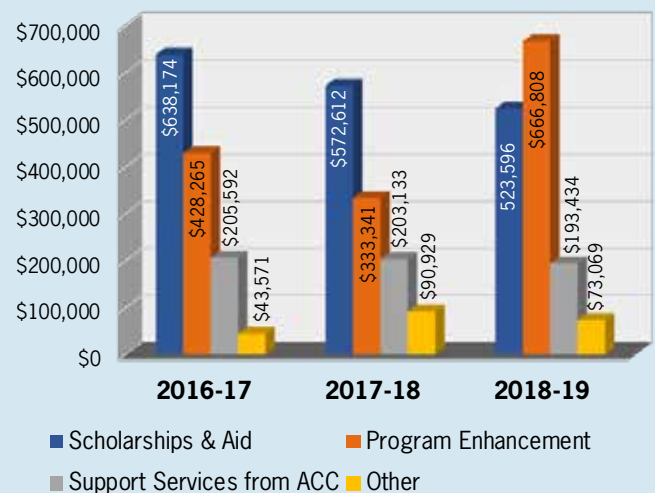
Designation of Endowed Funds

Ways to Give

Cash

- Cash gifts are immediate and, if you itemize your taxes, your outright gifts of cash are fully deductible for federal income tax purposes.

IRAs or Retirement Plan Assets

- You could leave 100% or a portion of the tax deferred retirement plan to ACCF. In order to modify your IRA beneficiaries, request a “change of beneficiary” form from your financial advisor.
- If you are over age 70½, then you can redirect all or a portion of your IRA’s Required Minimum Distribution to ACCF. This is called a Qualified Charitable Distribution. This distribution serves to satisfy all or part of your RMD requirement and prevents the distribution from being taxable.

Appreciated securities

- Gifting long-term appreciated stock, bonds, ETFs or mutual funds may offer you a two-fold tax savings:
 1. You avoid paying capital gains tax on the increase of the value of the securities.
 2. You receive a tax deduction for the full fair market value of the securities at the time of donation.

Non-Cash Donations & Real Estate

- Certain programs at ACC may benefit from donations of non-cash items that help educate students in current technologies. Examples of such donations include specialized program-related equipment in working order and hands-on training supplies. Such donations may be tax-deductible.
- Outright gifts of real estate allow the donor to avoid capital gains tax and realize a charitable deduction on the full fair market value of the real estate.

Bequests & Life Insurance

- After providing for loved ones, you could name ACCF as a beneficiary of a percentage of your assets in your estate planning documents or as a beneficiary to any unnecessary life insurance to establish a permanent legacy of helping ACC students. Please consult with your estate planner or life insurance agent to implement these strategies.
- You could inform your loved ones you would like ACCF to receive memorial gifts in your obituary.

Charitable Gift Annuity

- You could transfer at least \$10,000 to ACCF now and receive a guaranteed above market rate of return for the remainder of your life. Immediate tax benefits may be realized.
- When the donor passes, the remaining asset value transfers to ACCF.

Charitable Remainder Trusts

- A Charitable Remainder Trust (“CRT”) is an agreement between you and a trustee to hold assets for a term. The term may be for the lifetime of you, your spouse and/or other beneficiaries or for a set period of time not to exceed 20 years. At the end of the term, the CRT’s remaining assets could be distributed to ACCF.
- During the term of the CRT, the trustee will distribute a sum certain or a fixed percentage of the trust assets determined by you to a non-charitable income beneficiary determined by you.
