




Alamance Promise is an equally important and life-changing initiative we kicked off this past summer that positively affects the futures of our current and new students. For a community college to have the ability and staffing to ensure that all students in need will have their tuition paid is nothing short of miraculous. Yet ACC and its Foundation have made that commitment, a gift that has been partially responsible for increasing our fall 2022 enrollment in this post-pandemic world we live in. We are proud to fulfill the promise of an education to our students that will keep them on a steady path toward a credential and goodpaying job or career. You can read all about it in this Annual Report.

Another promise that we have confidence will make our college stronger is the ACC @ UNC Dental Assisting program that provides opportunities for students primarily in Orange and Durham counties to earn their ACC dental assisting credentials on the UNC campus without having to make the long and costly commute to Alamance County. ACC instructors will provide them the same education our local students receive but in a location closer to their homes. It's a win-win for both ACC and UNC as the university's dentistry students can work side-byside with our students, both groups learning from one another.

You will also read in this report about our team of experienced Success Coaches who became a strong presence on our campus this past summer. Their very important role is to help every credential-seeking student throughout their academic journey no matter what pathway they are following.

I trust this year's Annual Report helps show all we do to serve our community. We are grateful for our community's continued support.

DEAR DONORS, ALUMNI, FACULTY, STAFF, STUDENTS, VOLUNTEERS AND FRIENDS:

As we emerge from the depth of the pandemic with you and all of our community partners, we are preparing for the promise of the future for all ACC students.

During 2021-2022, nearly 1,000 students received financial assistance from the ACC Foundation. In January 2022, the ACC Foundation Board voted to provide nearly \$200,000 to make technology and environment improvements throughout the Carrington-Scott campus and to purchase a heavy equipment simulator for students to learn safe operating skills. This year, the Foundation also awarded seven faculty and staff members with a total of \$28,000 to implement innovative ideas and programs. In addition to continued support for Academic and Career Readiness student resources and enhancements of the Advertising and Graphic Design Makerspace, projects included a partnership with Elon University to celebrate Constitution Day with new United States citizens, the purchase of a pediatric manikin for dental assisting students, the "Feeding Hungry Minds" project that coordinated with the horticulture department to provide fresh food for students in need, support for IT students to enhance learning by participating in annual competitions, and the WiSDEM (Women, Industrial Science, Design, Engineering, Manufacturing) summer camp for middle school girls.

Among the new funds created this year are the Lucianna Cassesse Memorial Scholarship for students in the Animal Care program, the ComTech Scholarship for Information Technology students, the Natalie Miles Ambassador and Alumni Council Fund, the Modern Automotive Scholarship for Automotive Technology students, and the John Russell Memorial Scholarship for students in the Mechatronics Engineering program.

The future is upon us as students and faculty prepare to move into the state-of-the-art Biotechnology Center of Excellence. It is upon us as staff begin to serve students in the newly constructed Student Services Building at the very front of campus. It is upon us as we provide hope to students with the ACC Promise Program. Like travelers on the nearby interstate, our students are on a variety of diverse journeys, and we are there to provide for their needs.

It is because of your support that ACC Foundation and Alamance Community College are able to prepare for and emerge into the future with progress and promise. We are grateful for your partnership in this very important endeavor.

ACC Guarantees Affordable College with 'Alamance Promise' Initiative

Alamance Community College introduced a new initiative in 2022 called Alamance Promise that ensures an affordable education for all students with financial need.

Under Alamance Promise, the ACC Foundation will provide donated funds to provide scholarships to qualified students not receiving federal Pell grants, state grants or named ACCF scholarships.

"This is about addressing the belief gap in our community, about letting families know that college is attainable for their children and for themselves, that they can believe a college education is within reach," said ACC President Dr. Algie Gatewood. "Alamance Promise will enhance enrollment and increase retention. This is also about making certain that educational

attainment for our underserved populations does not end with a high school diploma."

"Through Alamance Promise, the ACC Foundation may also pay for supplemental needs such as licensure exams or the cost of field trips, as well as short-term assistance such as housing costs, utilities or childcare," said Carolyn Rhode, Executive Director of the ACC Foundation. "These are costs not normally covered by state and federal grants."

At the beginning of the Fall 2022 semester, 50 students had been awarded through the Alamance Promise process, an investment equaling approximately \$50,000.

During a press briefing last summer about Alamance Promise, Governor Roy Cooper joined virtually to praise ACC's initiative. "Our community colleges are our 'not so secret weapon'

when it comes to building a talented workforce and a stronger economy," said Cooper. "With this scholarship, Alamance Community College is making sure everyone has an opportunity to get a good job."

Dr. Gatewood praised the commitment of the ACC Foundation Board of Directors to facilitate the *Alamance Promise* program. The Foundation's endowment is comprised of more than 150 restricted funds. Total accrued financial assets of the ACC Foundation as of June 30, were nearly \$18 million.

Two Major Construction Projects Head Toward Early 2023 Openings

Construction of two major capital projects headed toward the finish line this fall with the Biotechnology Center of Excellence facility and the Student Services building both expected to open in early 2023.

BIOTECHNOLOGY CENTER OF EXCELLENCE

ABOUT THE PROJECT:

The Biotechnology Center of Excellence, now approaching completion, will be a freestanding, threestory, 30,000+ square foot structure, hosting a mix of labs and classroom space serving the Biotechnology, Medical Laboratory Technology, Histotechnology and Agricultural-Biotechnology programs.

The building's highly visible location along I-85/40 will provide indoor/outdoor learning spaces that align with the needs of students, faculty, and industry partners.

The Center's mission is to serve as a regional hub for innovative, industry-supported and technology-based workforce development and jobs in the rapidly expanding field of biotechnology that supports the economic vitality of Alamance County.

Alamance Community College is positioned – geographically and strategically – in the middle of North Carolina's most active biotechnology corridor. Indeed, Burlington is the nation's #1 small Metropolitan Statistical Area for research, testing and medical labs.

ABOUT THE PROJECT:

The new Student Services Center relocates and enhances space for Admissions, Registrar's Office, Financial Aid, Student Payments, and the Office of the Vice President for Student Success. Included also will be a ground floor multipurpose space that can be subdivided into three meeting areas by use of sliding partitions. Upon completion, it will serve as the new entrance to the campus core providing students with a single location to register and pay for classes, apply for financial aid, and talk to academic advisors.

RENOVATED 'AGRICULTURAL BUILDING' FOR ANIMAL CARE AND HORTICULTURE



The newly christened Agricultural Sciences Building is the new home to Animal Care & Management and expanded space for Horticulture Technology.

Renamed Agricultural Sciences, the former shop building on the north side of campus underwent a major renovation and expansion to create a reimagined space for the award-winning Horticulture Technology program and Animal Care and Management. Both programs moved into their new locations in September 2021.

ABSS EARLY COLLEGE MOVED INTO NEW CAMPUS SPACE

The ABSS Early College had occupied classrooms in the main building for several years. Underway in summer 2021, a complete refurbishing of the ground floor of the B-Building provided a new home to the Early College by January 2022. This space became available following the departure of the EMS program to a new location in the same building.

NEW CAMPUS DINING/COMMONS OPENED TO STUDENTS

The reimagining of the Dining/Commons area in the main building allows students to socialize, study, and dine in an innovative space more conducive to students' needs. It opened to them in spring 2022 at a cost of \$1,065,000.

NATIVE PRAIRIE AND OUTDOOR CLASSROOM

EMERGENCY MEDICAL SERVICES (EMS) **RENOVATION & EXPANSION**

- Project: \$335,600 (County Capital Reserve funds)
- Construction completed: August 2021

As part of the overall College Facilities Capital Plan, a new dedicated location for the Emergency Medical Services (EMS) program was initiated and completed in spring 2022. Six classrooms on B-Building's second floor were up-fit to provide the EMS program with proper teaching and learning classrooms and labs in order to grow and meet required credentialing and accreditation standards. Among the highlights of this high-tech, fully functional space are:

- An on-site simulated ambulance equipped with lights, sirens, and state-of-the-art technology to emulate real life scenarios students will experience working in the field. The ambulance is equipped with a high-quality camera system for instructors to monitor and play back different classroom scenarios.
- A classroom with windows that can be blacked out to create a night-like setting in which students will learn to operate patient simulators controlled by instructors to teach students to learn in a fast-paced environment.
- A simulated ER bay and a one-bedroom apartment to acclimate students to working environments they will typically respond to in the field.


COLLEGE AWARDED \$24.9 MILLION IN GRANTS BETWEEN 2019-2022

Alamance Community College received \$24.9 million in state, federal and independent grants over a three-year span from 2019 to 2022. These important gifts undergird the College's efforts to move forward on important, studentoriented programs and equipment that are crucial to implementing high educational and job-training initiatives for Alamance County students.

\$2.1 MILLION FED GRANT **FUNDS SUCCESS COACHES**

ACC received a highly competitive \$2.1 million federal grant from the Department of Education to support the college's PACE success coaches. PACE (Persistence from Application to Completion in Education) is ACC's self-titled initiative that partners professional success coaches with students throughout their time at ACC.

Like many two-year schools, ACC has grappled with student retention rates. Traditionally, students in the community college system face a multitude of challenges

balancing work, education, finances, and family obligations. This grant provides additional staff equipped to provide the support students need throughout their tenure on the ACC campus.

Success coaching on college campuses is a powerful tool because the coaches use predictive analytics and proactive case management to monitor student grades, attendance, and more to provide outreach to students when they need it the most.

FOUNDATION MEDICINE DONATION SUPPORTS HISTOTECHNOLOGY LAB

ACC received a generous donation from Foundation Medicine, a pioneer in molecular profiling for cancer, to support the establishment of a new Histotechnology laboratory in the soon-to-be-open Biotechnology Center of Excellence.

Once its doors officially open in early 2023, the Center of Excellence will feature a mix of laboratory and classroom space for the College's Biotechnology, Medical Laboratory Technology, Histotechnology and Agricultural-Biotechnology programs.

Due to its significant donation, Foundation Medicine has been granted naming rights for the Histotechnology laboratory support space.

"We are honored to have forged this synergetic partnership with Alamance Community College and are eager to provide a state-of-the-art instructional space for future Histotechnologists to hone their skills," said Sara Beckloff, Foundation Medicine's Research Triangle Park Site Head and Senior Director, Laboratory Operations.

"Partnerships with pioneering companies like Foundation Medicine are instrumental in helping us launch new programs to build industry expertise and talent, and drive innovation," said ACC President Dr. Algie Gatewood.

GRANT HELPS DEVELOP COVINGTON EDUCATION CENTER FOR AGRICULTURE EDUCATION

The North Carolina Tobacco Trust Fund Commission awarded a \$380,550 grant to develop the Bill and Nancy Covington Education Center and provide hands-on and real-world learning for agriculture and horticulture students.

The College received the funds specifically for "Agricultural Learning Through Farm Development," a \$9.1 million project that signifies the initial development of the Bill and Nancy Covington Education Center, a 47-acre parcel. A generous donor provided funds for the land's purchase in 2015. The Center's development will impact students in Horticulture Technology, Animal Care and Management, Agricultural Biotechnology,



and several new programs that began this fall: Agriculture Education, Sustainable Agriculture, and Agribusiness Technology.

In addition, two Career College pathways offer training for students with intellectual disabilities in both Horticulture and Animal Care, serving 25 students each year who will benefit from expanded farm resources.

Tobacco Trust funds will assist ACC in developing more usable learning spaces and resources. Specifically, the project will provide access to a more reliable water source to support current and future growth, establishment of a teaching and restroom facility, and creation of an animal husbandry barn and grazing areas.

"There is a tremendous amount of potential for new and unique learning opportunities for students at the Covington Center," said Dr. Elizabeth Riley, Department Head of Horticulture Technology and associated programs.

Additionally, ACC's training activities will support a blend of new and current farmers. The project will help provide training opportunities to existing farmers looking for alternatives to tobacco production and new farmers who are beginning to take over family farms or start new farms in Alamance and surrounding counties.

NCCCS GRANTS SUPPORT **MULTICULTURAL MALE** SUCCESS INITIATIVE

The College received two grants that, together, support ACC's Multicultural Male Success Initiative (MMSI).

The NC Community College System awarded ACC a \$171,276 MMSI grant to help guide the academic progress and program completion of minority males. The grant supports four years (July 2022-June 2026) and, along with institutional funds approved by ACC's president, supports the salary of one full-time MMSI

success coach/mentor. The MMSI coach will work actively to guide and connect minority male students to ACC's existing academic, financial, and advising services. The MMSI coach will work individually with students to strengthen their goal-setting, problem-solving, and career planning skills. Dr. Thomas Barksdale was hired this year to fill the position.

Another grant that supports MMSI was a \$106,117 Longleaf Commitment Underserved Students Outreach and Advising Project grant from the NC Community College System. This grant (\$88,432 combined with the College's required match of \$17,685) runs from March 2022 through December 2024. ACC is using these funds to provide partial support of the MMSI success coach salary, and provides a small support budget for student outreach materials and staff training.

\$3.6 MILLION STATE APPROPRIATIONS GRANT FINANCES BIOTECH EQUIPMENT

In November 2021, Gov. Cooper signed into law the \$25.9 billion budget plan which included a \$3.6 million appropriations grant for the purchase of lab equipment for ACC's Biotechnology Center of Excellence, due to open soon. Instrumental in pushing the package through was NC State Senator Amy Galey, a Graham resident.

The \$39 million capital bond package, approved by Alamance County voters in 2018 for construction of the Biotechnology Center, did not include funding for science lab equipment and funding had to come from another source.

ACC PARTNERS WITH NC A&T ON \$23.7 MILLION GRANT FOR CLEAN ENERGY WORKFORCE TRAINING

The U.S. Department of Commerce awarded a \$23.7 million American Rescue Plan Good Jobs Challenge grant to NC A&T State University this summer to create a clean energy workforce training program, of which Alamance Community College is a partner.

With a focus on equity, the program will use mobile training units in 16 NC counties – including Alamance County -- to remove barriers to access and deliver training where workers are. Significantly, more than 40 employers have committed to hiring 3,000 trainees over four years, then 1,500 trainees every year afterward.

ACC will participate in the development of college curriculum for apprenticeships and use funds for student support and services. Specific action steps will be developed during the planning phase of the project next year, but may include:

- Recruitment for summer pre-apprenticeships;
- Promoting, recruiting, and participating in the full apprenticeships for academic year 2023-2024;
- Conduct the full apprenticeships established for replicating the same standardized curriculum in all NC community colleges;
- Recruit students from high schools to participate.

20 STUDENT APPRENTICES CELEBRATE **GRADUATIONS, NEW SIGNINGS**

ACC hosted a combined graduation/signing ceremony in August for 20 high school and adult students enrolled in a variety of apprenticeship programs.

High school apprentices were joined at the event by other youth and adult apprentices in manufacturing and skilled trades, including horticulture.

Alamance County's apprenticeship program was initially designed for high school juniors and seniors who can earn a paycheck on the job as soon as they begin the apprenticeship program while also taking college classes. However, the College's apprenticeship portfolio has expanded over the past few years and now includes incoming high school students, current college students, and non-traditional adult students.

The Alamance County apprenticeship program is a joint partnership between Alamance Community College, Alamance-Burlington Schools, and more than two dozen businesses including all apprenticeships at ACC. It is sanctioned by ApprenticeshipNC.

Seven student apprentices graduated from the program after working at GKN Driveline, Nature Select, RegO Products/ECI, Fairystone Fabrics, and AKG. They earned associate degrees in June 2022 and had worked full-time as apprentices since 2017.

For all apprentices, tuition, books, and fees for the associate degree program are covered by most companies, allowing the students to graduate debt-free. Most apprentices complete about 8000 hours, comprised of 6400 hours working as apprentices and 1600 hours learning in ACC classes.

Signing agreements with ApprenticeshipNC to begin their formal apprenticeships were six high school students who are ACC freshmen, and seven adult ACC students.

TRUSTEES APPROVE COMPETITIVE GAMING OPPORTUNITY

ACC's Board of Trustees unanimously approved the administration's request to use \$55,000-\$65,000 in institutional funds from bookstore commissions to purchase 15 special computers for a new competitive video gaming program.

The College recognized that Esports is a multi-billion dollar industry worldwide and is only gaining momentum. Alamance Community College realized this and wanted to be part of something that would not only add to the college experience of those participating, but also provide an opportunity to increase enrollment.

Student athletes who participate will be members of the National Junior College Athletic Association and must maintain satisfactory academic status with the institution.

ACC plans to begin competition in the Spring 2023 semester.

ACC EXPANDS DENTAL ASSISTING PROGRAM TO UNC CAMPUS

ACC's long-running Dental Assisting program is expanding its offerings for prospective students who live east of Alamance County by opening a satellite campus at the University of North Carolina at Chapel Hill starting in January 2023.

ACC at UNC, as the new cohort is known, will allow ACC students to utilize the Adams School of Dentistry facilities where UNC operates its renowned dentistry school.

By operating this satellite campus, ACC will offer its full

Dental Assisting diploma program for students who primarily live in Orange and Durham counties. No dental assisting program currently exists in those counties.

"Our state is experiencing a severe shortage of dental assistants, and the increased number of graduates, up to 24 per year that this partnership is expected to produce, will have a tremendous impact on alleviating the critical shortage," said David Frazee. Dean of Health and Public Services at ACC.

Students have the choice to complete their general education courses in the fall semester, either online or in person on the main ACC campus. Accepted students will then begin inperson classes and labs on the UNC campus in January 2023.

FIRST FEMALE ACC STUDENT EARNS APPRENTICESHIP CREDENTIALS

Victoria Rose, a 2021 ACC graduate, became the first female apprentice to complete the Alamance Career Accelerator Program (CAP) while gaining work experience and a paycheck.

Victoria achieved three key milestones while she matriculated through the program: she earned an Associate in Applied Science in Mechatronics Engineering Technology after four debt-free years; she has a guaranteed fulltime job with Engineered Controls International (ECI), LLC, in Whitsett, NC; and she earned a Journeyman Certificate from the NC Department of Commerce. The Career Accelerator Program (CAP) allows qualified high school students to

attend ACC part-time, work part-time, and graduate after four years debt-free with an associate degree and a guaranteed full-time job.

CAP graduates complete approximately 8,000 hours, comprised of 6400 hours working as apprentices and 1600 hours learning in class. All tuition, books, and fees for the associate's degree program are covered, so the students graduate debt-free. Alamance CAP is recognized by the State of North Carolina as a registered apprenticeship program.

Victoria Rose, a Cummings High graduate, had long aspired to become an engineer. The existence of the Career Accelerator Program convinced her to enroll in ACC's Mechatronics Engineering program.

Victoria's apprenticeship—and now a full-time job—took her to ECI in Whitsett where she is responsible for quality control.

Over the past four years, Victoria learned to navigate job responsibilities while earning a degree, discovering new skills while improving on others. "I definitely have more confidence and better communication skills," she said.

Victoria Rose has a solid future ahead but she is not finished with her education. "I plan to come back to ACC to earn my degree in Computer-Integrated Machining," she said. "It's a win-win situation."

COLLEGE ADDS EIGHT NEW PROGRAMS OVER PAST YEAR

In the time period from July 1, 2021 to June 30, 2022, ACC received approval from the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) to offer the following new curriculum programs:

- Sustainable Agriculture
- Agriculture Education
- Agribusiness
- Emergency Medical Science

During this time period, ACC also received SACSCOC approval to offer the following existing programs fully online:

- Business Administration
- Information Technology
- Criminal Justice Technology
- Accounting and Finance

These four programs are now offered fully on-campus and fully online.

818 GRADUATES EARN CREDENTIALS AT FIRST IN-PERSON COMMENCEMENT SINCE 2019

The College held its first in-person commencement exercises in two years in June 2022, providing 818 graduates of curriculum and GED/Adult High School programs the opportunity to celebrate at the ceremony held on the Elon University campus.

Due to the Covid-19 pandemic, commencement was held virtually in 2020 and 2021 as graduates watched from the comfort of their own homes. With health safety protocols relaxed nationwide, the Class of 2022 returned to a more traditional event.

COMMENCEMENT - BY THE NUMBERS

- The College conferred degrees, diplomas and certificates on 726 curriculum students, 79 GED/HiSet, and 13 Adult High School for a total of 818 graduates overall.
- 172 graduates received Honors and 140 earned High Honors among the total curriculum graduates.

103 HIGH SCHOOL STUDENTS EARNED COLLEGE CREDENTIALS

This number includes:

- 68 high school students (Career and College Promise pathways and ABSS Early College) earned Associate in Arts degrees with 60 college credits -- allows them to transfer with full Junior class status
- 35 high school students earned certificates or diplomas in various career technical programs



ACC PARTNERS WITH ELON, ABSS FOR **ALAMANCE SCHOLARS PROGRAM**

ACC partnered with the Alamance-Burlington School System (ABSS) and Elon University for the Alamance Scholars program, designed to support students pursuing a teaching career and returning to the local community upon college graduation.

Candidates enter Alamance Scholars through two pathways. First, candidates may enter as an ABSS high school student via the Teacher Cadet I course. Second, candidates may enter as an ACC student. Alamance Scholars candidates attend ACC and Elon University to earn, consecutively, associate and bachelor degrees to become a PreK-12 teacher.

This fall, five Alamance Scholars students are participating in ABSS's Teacher Cadet I course; Eastern Alamance High graduate Erin Wheeley is currently enrolled at ACC; and recent ACC graduates Riley Fennelle and Mae Williams are attending Elon University.

ACC SELECTED FOR RACIAL EQUITY COLLEGE NETWORK

ACC was one of 20 North Carolina community colleges selected to participate in the Racial Equity for Adult Credentials (REACH), a network that provides campuses with access to resources such as training and technical assistance, shared strategies to reduce educational attainment gaps, improving outcomes for adult learners, and strengthening its talent pipelines.

REACH, a subsidiary of Higher Education Collaborative, was created to advance

equitable outcomes and credential attainment for adult learners of color.

ACC created a commission last year on Racial Equity, Diversity and Inclusion (REDI). This commission, comprised of leaders within the college, was endorsed by the ACC Board of Trustees, the president, and executive leadership.

"Having support from the administration sets the tone for the entire institution as we work to identify strategic ways and partnerships to increase success and reduce barriers," said Josefvon Jones, Director of Diversity and Inclusion.

"Alamance Community College recognizes the importance of diversity as it is the cornerstone of what we do and how we serve," said ACC President Dr. Algie Gatewood.



ACC HORTICULTURE STUDENTS EXCEL AT NATIONAL LANDSCAPING COMPETITION

Horticulture Technology students excelled at the 46th National Collegiate Landscape Competition last March as the team finished 10th among 43 colleges and universities from across the U.S.

Held at NC State University, ACC's 16 students matched their horticulture and landscaping skills in contests against 510 competing students. Individual students and teams placed high in the competitions to accumulate scores that pushed ACC into the upper echelons of the competition.

Among ACC's 42 competitors were the likes of Auburn University, Michigan State University, NC State, and approximately 12 community colleges.

This was the 19th consecutive year that ACC's Horticulture department had attended this national event, including virtual events due to COVID-19 the past two years. The annual event provides students opportunities to spend a day in workshops led by industry professionals, attend a career fair featuring more than 50 top landscape companies from across the U.S., and pit their horticulture skills in numerous competitions.

"Our students put in hours of preparation time and worked diligently at their competitions. They competed against others with huge teams and some from large four-year universities, and they still came out on top," said Dr. Elizabeth Riley, Department Head of Horticulture Technology at ACC, who accompanied the team to the event.

ACC'S FIRE PROTECTION PROGRAM **RANKED IN** TOP TEN NATIONALLY

Alamance Community College (ACC) was ranked ninth in the Top 10 Online Associate's in Fire Science Degrees for 2022 by Online Schools Guide.

Online Schools Guide has been providing advice, resources, and rankings on the best online undergraduate and graduate degree programs since 2018.

ACC's online Associate in Applied Science in Fire Protection Technology is a stackable degree program. Students earning the 15-credit certificate take the same classes as the degree students. After earning a certificate, students can earn a 33-credit diploma and then a 63-credit associate's degree. Designed to save time and money, this stackable fire safety program provides a guided degree path for the student.

According to the website, the Online Schools Guide editors found schools offering online or hybrid Associate Degrees in Fire Science. Then they ranked the programs based on cost, reputation, and future salary. "Alamance Community College's program is a fine addition to the country's quality online associates of fire science degrees," stated Online Schools Guide on its website.

For seasoned firefighters, an associate's degree in Fire Science can open up highertiered jobs within their local fire departments, such as a captain or a deputy fire chief. Firefighters can also become a manager of the customer-facing side of the fire department.

GRADUATE SUCCESS: ACC STUDENT WINS JOB AS COUNTY'S HR DIRECTOR

When Ashley Kirby Powell was growing up on her family's tobacco farm 30 years ago, she probably never imagined she would one day take charge of the welfare of dozens of employees who work for Caswell County Government. Yet that is precisely where she finds herself this fall, thanks to perseverance and working toward an associate's degree at Alamance Community College.

As a young girl, Ashley watched her father work their Caswell County tobacco farm while her mother toiled in a factory. After graduating from Bartlett-Yancey High School in 2002, she began a job with the child nutrition department at Caswell County Schools.

"I didn't have the highest paying job but I loved it because of the children," said Ashley. "For many of them, I was the only smiling face they may see or providing them the only meal they may eat for the day."

After 13 years in that field, Ashley turned to Caswell County Government in 2017 as an administrative assistant. It was there that her supervisor saw potential in her as she often worked closely with the Director of Human Resources for the county. Ashley's supervisor recommended that she sign up for human resources classes.

That is how Ashley came to enroll at Alamance Community College. "I found that ACC was the only college around that offered any classes focused on HR [Human Resources]," she said. "I was impressed that I could take most of my classes online. This was a must for me working 40-plus hours a week and being a mother of three kids. I was really worried that I couldn't handle going back to school with my crazy schedule but the flexibility of classes made it work."

Ashley was required to attend one class two evenings a week at ACC while she studied for her degree. "It was my first time attending a college class in person, and I was super nervous. But it proved to be the best experience."

Ashley found the small class size and various ages of the students appealing. But it was her connection with her instructor that made a big difference for Ashley.

"My instructor, Ann Snell, was awesome," she said. "She made learning fun and interesting. Not only was she my instructor, but she became a friend and we still stay in touch to this day. She has inspired me so much."

"Ashley added so much value to the human resources class during my first semester teaching at ACC," said Snell. "She already had real-life HR experiences to share with her classmates. It is very gratifying to see Ashley now achieve her current career goals."

Recently Ashley learned that the Director of Human Resources for Caswell County, with whom she was already working, was retiring at the end of the year.

"I knew with all the hard work, dedication, and knowledge that I have gained from ACC and while on the job had prepared me to fill that role," said Ashley.

Ashley began the interview process on September 12 and soon the Caswell County Manager and the retiring Human Resources Director made a recommendation to the Caswell County Board of Commissioners. On September 19 following a closed session, the board made Ashley a job offer as the new Director of Human Resources to begin in January. The current Human Resources Director plans to stay through December to help transition Ashley into her new role.

"The knowledge and the relationships that I have built and retained while studying at ACC will carry on with me for a lifetime," she said. "Not only that, but I gained confidence as a person and confidence in my work."

Ashley Kirby Powell expects to earn her associate's degree from Alamance Community College by fall 2023. By then, she will have a year of experience as Director of Human Resources for Caswell County, a career launched by her success at Alamance Community College.

ACC BIOTECHNOLOGY STUDENT SELECTED FOR NATIONAL IMMERSION WORKSHOP

A 2022 Biotechnology graduate spent the week after ACC's commencement at a summer immersion program that provided opportunities to learn about the pharmaceutical industry and a chance to network with industry professionals.

Jeffry Garcia, 26, of Burlington traveled to Philadelphia, Pa. days after his graduation from ACC to take his place among 20 fellow college science majors in a nationally competitive program operated through the University of Delaware and the National Institute for Innovation in Manufacturing Biopharmaceuticals (NIIMBL).

"This is a tremendous opportunity for a community college student like Jeffry to compete on a national level with students at four-year universities. We are extremely proud of his achievements," said Michelle Saboun, Department Head of Biotechnology at ACC.

Funded by an arm of the U.S. Department of Commerce, the workshop was geared toward minority college

underclassmen and is an exclusive in-person, all expenses paid immersion program designed to introduce them to biopharmaceutical careers. Through hands-on learning and personal interactions, students had an opportunity to earn a deep understanding of how the industry and federal agencies work together to develop and manufacture life-saving medicines.

Jeffry Garcia dropped out of high school, worked various jobs over the next few years, and eventually earned his GED. But he had always cultivated a great interest and talent for biology. He enrolled at ACC and completed the biotechnology degree program in one year.

Garcia's goals after graduating from ACC include working at Research Triangle Park in molecular biology.

One of those 'right' decisions came in late 2021, when Claire learned she had been accepted to Baylor University in Waco, Texas. Baylor consistently ranks in the top 100 in America's Best Colleges by U.S. News & World Report.

DISTANCE LEARNING

PROGRAMS ADDED ONLINE

During the 2021-2022 year, most ACC classes continued to have an online presence. The need for remote instruction continued to be strong.


During the spring 2022 semester, the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) approved the Associate in Applied Science degree in Information Technology, Business Technologies, Criminal Justice, and Early Childhood Education to be delivered 50% or more via a distance education method of delivery effective for fall 2022. These additions to our online programs will strengthen ACC's online presence.

ENROLLMENT

During the 2021-2022 academic year, ACC's online course enrollment accounted for 50% of total curriculum enrollment. When combined with hybrid and blended courses, this percentage increases to 82%. This year, most courses had some online presence as a result of the COVID-19 pandemic. Last year ACC offered 978 fully online sections, 465 hybrid courses, and 167 blended courses. While the number of fully online sections decreased in the 2021-2022 year, fully online courses remained above the 25% average for online learning.



NEW INITIATIVES

During the 2021-2022 year, the Distance Learning Center acquired the Simple Syllabus application to be used beginning in 2022-2023. Simple Syllabus is an online syllabus application that will allow for standardized syllabi across academic programs. Once fully implemented, students will have the opportunity to preview course syllabi prior to registration.

The Distance Learning Center also launched a Quality Matters Committee to help guide the implementation of Quality Matters on campus. Quality Matters is a nationally recognized quality assessment program used in online courses. The Quality Matters program will be used to evaluate and guide development of online courses.

ACC FOUNDATION AWARDS GRANT FOR DREAM CENTER **STUDENTS**

Among faculty/staff grants awarded by the ACC Foundation last summer was one for \$10.000 to the Academic and Career Readiness (ACR) department to support childcare at Burlington's CityGate Dream Center.

CityGate Dream Center in east Burlington has hosted classes sponsored by the College's ACR department since fall 2018. The \$10,000 grant helps support the childcare it provides for children of students in the High School Equivalency (HSE) and **English Language Acquisition** (ELA) morning classes.

Carolyn Rhode, Executive Director of the ACC Foundation, said, "We are grateful for the support of many donors who provide flexible funding to help students beyond traditional scholarships. Extras, such as childcare, ensure community members acquire the skills needed to be active workforce participants."

ADULT EDUCATION PROGRAMS EXCEED STATE EXPECTATIONS

The Academic and Career Readiness (ACR) department received a platinum status for exceeding excellence on the NC report card that assesses schools' progress in adult education programming.

ACR also ranked third in the state for Multiple Skills Gain for the number of students achieving an increased educational level on an assessment, an attainment of a secondary school diploma, or employment attainment.

ACC's Academic and Career Readiness budget, a combination of federal and state dollars, increased by almost ten percent during a challenging program year.

ACR serves students who are non-traditional, diverse, and are considered hard to serve populations under the Title II (WIOA) Workforce Innovation and Opportunity Act.

Students learned digital literacy in the program coordinated by the Academic and Career Readiness division.



COLLEGE USES \$25,000 GRANT TO TEACH DIGITAL LITERACY

ACC was one of 43 Title II programs to receive \$25,000 from the state to create a Digital Navigator Network. The staff training will develop best practices in providing instruction to improve digital literacy resulting in certificates for students.

"This has been one of the most significant things we have done to support and prepare our students for college transition, the workplace, and daily life," said Jennifer Mock, Director of Academic and Career Readiness at ACC. "To date, we have had 286 credentials and 628 badges earned on the North Star digital platform. Our plan is to continue to implement in every class in our program, as well as reach out to

the community who may want to take advantage of a free digital literacy course."

WORKFORCE DEVELOPMENT

SMALL BUSINESS CENTER

The Small Business Center (SBC) provides seminars, confidential counseling, employee training, robust resources on business operations and capital formation for existing enterprises and operations to be. It works cooperatively with the Chamber of Commerce, local municipal business corporations, and industry experts.

CEO INITIATIVE AWARD

The SBC awarded two entrepreneurs a total of \$10,000 for their winning projects as part of the annual CEO Initiative Award competition.

First place winner Feraud Calixte won \$7,000 for his small business that seeks to rent out residential and company spaces to other business owners. Second place winner Onita Williams received \$3,000 for her temp agency project that will make connections between stylists and salons.

The CEO "Business on the Basics" program prepares budding or veteran business owners in developing entrepreneur skills to successfully achieve their aspirations. All candidates in the competition received guidance from mentors in business law, accounting, finance and banking. Participants learned through a combination of case studies, lectures, seminars, panel discussions and in teamwork settings.






■ During the 2021-2022 fiscal year, ACC Corporate Education division managed a number of Customized Training Projects with a total project budget of \$1,204,905.

FINANCIAL AID 2021-22






Selected Financial Aid Programs




Current Fund Revenues: \$44,506,831*

RETURNS


The year ending June 30, 2022 was not pretty. The fund return for that fiscal year was negative 13.5%. There continues to be a fair bit of volatility in values as the market absorbs information about the U.S. elections, the war in Ukraine and associated impacts on grain, oil, natural gas and other commodity prices, inflationary fears and expectations, and new COVID-19 variants impacting global supply chains. In times such as these, the Investment Committee finds it helpful to look at the longer term. On June 30, 2021, we had experienced a \$4 million increase or a 33% return for the year on our invested assets. The next year we saw a \$2 million loss, for an overall \$2 million net gain.

Endowed funds are invested for perpetuity. So, in times such as these it is comforting to know that the 10-year compound annual return was over 7%. This covers the 5% spend rate with an allowance for historical inflation.


MANAGEMENT

An Investment Committee, consisting of ten experienced volunteer business professionals, oversees the ACC Foundation financial assets. The Investment Committee establishes policies for the management of the assets and employs Trust Company of the South (TCTS) to carry out day-to-day investment activities.

FALL 2022: FOUNDATION SCHOLARSHIP AWARDS RISE

Due to strong and focused marketing of the Alamance Promise program, the ACC Foundation spent over \$225,000 in scholarships for Fall 2022. This represents a 54% increase over the prior year and puts the ACC Foundation on track to invest nearly \$600,000 for the 2022- 2023 school year.

FOUNDATION GRANT UPGRADES CLASSROOMS

The ACC Foundation Board of Directors approved \$147,388 to fund a faculty request to upgrade the instructional functionality of general education classrooms in three older buildings. The refurbishment and upgrades allow for more ACC faculty to have access to smart boards and technology that facilitates hybrid instruction (simultaneous seated and virtual). Aging tables and chairs were replaced with movable furniture that facilitates both lecture-style instruction and group work. In addition, the new furniture can be more easily and thoroughly cleaned to guard against the spread of COVID-19 and other communicable diseases. The grant supported ACC's Strategic Plan by providing resources that allow faculty to use best practices for teaching to improve student success.

ANONYMOUS FAMILY FOUNDATION **WORKS WITH ACC TO BRING STEM** SUPPLIES TO ABSS MIDDLE SCHOOLS

An anonymous family foundation awarded the ACC Foundation \$84,000 to strengthen the K-12 to ACC pipeline. Funds were used to provide STEM supplies to each of the traditional ABSS middle schools, the Alamance Virtual School and Ray Street Academy.



Among the purchases were:


- A working watershed model for Turrentine Middle School
- A sun, moon and planet orbital model for Broadview Middle School
- A camera to project STEM experiments to a classroom at Graham Middle School
- A BrainPOP online math and science software subscription for the Alamance Virtual School
- Access to 70 science kits from the Center for Inquiry Based Learning (CIBL) tailored to North Carolina Learning Standards. Each kit serves 125 students and covers topics such as geology, genetics, and chemistry. STEM teachers at each of the ABSS middle schools can request the kits.

ABSS middle school teachers can link the supplies and instruction to programs at ACC, thereby increasing students' awareness of local rigorous STEM-related college opportunities.

FOUNDATION NEWS

DUKE ENERGY GRANT FUNDS PRE-APPRENTICESHIP PROGRAM

The ACC Foundation is managing a Duke Energy grant that funded a four-week adult pre-apprenticeship. Pre-apprentices were introduced to fundamental employment core skills such as workplace safety, communication, tools and equipment, and employability. The students participated in hands-on training in Computer-Integrated Machining, Welding Technology, Air Conditioning/Heating & Refrigeration, Mechatronics Engineering Technology, Computer-Aided Drafting Technology, and Automotive Systems Technology, as well as Lean Six Sigma's White Belt and Yellow Belt soft skills training. At the conclusion of the 160-hour pre-apprenticeship program, ACC invited local employers to meet the graduates and conduct interviews.



The Foundation helped facilitate an in-kind donation of 15 Ultimaker-3 3D printers, valued at over \$10,000 from Duke University's Innovation Co-Lab. The gift was secured as part of an initiative with the NC Educational Makerspaces.

The 3D printers were set up in the makerspace classroom located in ACC's Advertising and Graphic Design department. The ACC Makerspace is expected to become a hub for innovation and collaboration among students, faculty and staff.

"Having so many 3D printers will allow students from many departments around the college to test and refine prototypes of designs," said Erik Perel, Advertising and Graphic Design Department Head who helped acquire the printers. "Additionally, students not familiar with 3D modeling and printing will be able to explore those concepts with fun designs they discover."



Pre-apprentices learned basic skills in welding and automotive departments, as well as many other areas.

ANNUAL REINHARTSEN 5K RAISES \$7.300 FOR SCHOLARSHIP

The College's Basic Law Enforcement Training (BLET) student team was the winner of the Chief Mike Woznick Cup.



The ninth annual Reinhartsen 5K, coordinated by the ACC Foundation, grossed \$7,300 for the Steven Reinhartsen Memorial Scholarship, named for a longtime ACC counselor who passed in 2012.

The November 2021 event saw more than 80 runners and walkers traverse the 3.1 miles around the main campus. The College's BLET (Basic Law Enforcement Training) group won the Chief Mike Woznick Cup trophy in honor of the late police chief of Gibsonville. They bested the running time of the group from the Burlington Police Department.

FOUNDATION AWARDS 9 FACULTY-STAFF GRANTS TOTALING ALMOST \$30,000

WAYS TO GIVE TO ACCF

Charitable Giving Overview

Charitable giving provides personal satisfaction to the donor along with estate and income tax deductions to reduce taxes.

From a financial planning perspective, lifetime charitable gifts are generally made to achieve income tax deductions and slow the growth of an estate. At death, if an estate plan is so arranged that the heirs will receive a satisfactory net inheritance then estate assets can also be left to charities via bequest. Charitable bequests are eligible for an estate tax deduction and must be made by the estate owner in the estate planning documents.

Advantages of charitable giving include:

- Immediate reduction in estate size.
- Income Tax Deduction if made during lifetime.
- · Sense of satisfaction for good works.
- Special charitable trusts exist that offer the above benefits and still provide the donor with income from the gifted asset.

Many people prefer using charitable gifts to reduce their estate tax liability because they believe their dollars are better spent and allocated by a charity or foundation than a wasteful or inefficient government department. Additionally, and especially with a foundation (like ACCF), the donor can better control which people/causes the money will help.

Below are several ways charitable gifts may be made to ACCF.

Cash:

 Cash gifts are immediate and, if you itemize your taxes, your outright gifts of cash are fully deductible up to 60% of AGI for federal income tax purposes.

Appreciated securities:

- A gift of securities can be a good option for accumulated stocks, bonds or mutual funds that have appreciated in value and would be subject to a 15% or 20% (based on tax bracket) capital gains tax if sold.
- Gifting long-term appreciated stock, bonds or mutual funds may offer you two tax savings:

Show your care for current and future ACC students by making an investment today!

- You avoid paying capital gains tax on the increase of the value of the securities.
- 2. You receive a tax deduction for the full fair market value of the securities at the time of donation.

IRAs or Retirement Plan Assets:

- Tax deferred retirement plans represent one of the most significant, yet underutilized potential gift planning assets. Charitable gifts of tax deferred retirement plans escape both estate and income taxation.
- If you are over age 70½, then you can direct an IRA distribution to a charity. This is called a **Qualified Charitable Distribution**. This distribution serves to satisfy all or part of your RMD requirement (RMDs begin at age 72) and prevents the distribution from being taxable. There is a \$100,000 annual limit.
- You could leave 100% or a portion of the tax deferred retirement plan to ACCF. In order to modify your IRA beneficiaries, request a "change of beneficiary" form from your financial advisor.

Bequests:

- After providing for loved ones, you could name ACCF as a beneficiary of a percentage of your assets in your estate planning documents to establish a permanent legacy of helping ACC students. Please consult with your estate planner to implement this strategy.
- In your obituary, you could inform your loved ones you would like ACCF to receive memorial gifts.

Non-Cash Donations and Real Estate:

- ACCF may benefit from donations of non-cash items that help educate students in current techniques and technologies. Examples of such donations include specialized program-related equipment in working order and hands-on training supplies. Such donations may be tax-deductible.
- Outright gifts of real estate allow the donor to avoid capital gains tax and realize a charitable deduction on the full fair market value of the real estate.


